

## THE MATTER OF THE PETITION FOR DETACHMENT LAND FROM THE CITY OF PRINCETON, MINNESOTA PURSUANT TO MINNESOTA STATUTES § 414.06

- 4. The property proposed for detachment is rural in character and not developed for urban residential, commercial, or industrial purposes. It has been and will be used for agricultural property.
- 5. The reason detachment is requested is it will be used for agricultural reasons with wells being used for irrigation systems.
