Pursuant to Minnesota Statute Section 412.091, the undersigned
petitioners hereby petition the Minnesota Municipal Board to call
a special election on the question of dissolving the City of
Island View, and state as follows:

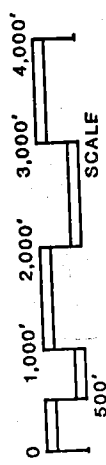
1. Seventy voters voted in the last city election.
2. All persons signing this petition are voters duly qualified
to vote in the city election for the City of Island View, and
28 voters have signed this petition representing at least
the statutory number required by Minnesota Statute Section
412.091.
3. The property abuts unorganized territory in Koochiching
County to the west, Ray Township-North to the South, unorganized
territory and the Voyageurs National Park to the east, and the
Country of Canada and organized territory of Koochiching County
to the north.
4. The number of acres in this property proposed for
dissolution is 2,224.90 acres, as evidenced by the Petition for
Election to Incorporate the Village of Island View filed for
record in the office of the Koochiching County Recorder as
Instrument No. 70506 in Book "T" of Misc. page 352 and 353.
5. The territory proposed to be dissolved consists of all of
the following sections lying within the boundaries of the United
States of America and of the City of Island View, Minnesota, all
located in Township 71 North, Range 22 West of the Fourth
Principal Meridian: Sections 19, 20, 21, 30, 29, 28, 31, 32 and
33.
6. The dissolution is requested because the majority of the
voters feel that there is no longer a need for the City to exist.
7. The undersigned believe the City of Island View will become
a part of the unorganized territories within the County of
Koochiching.

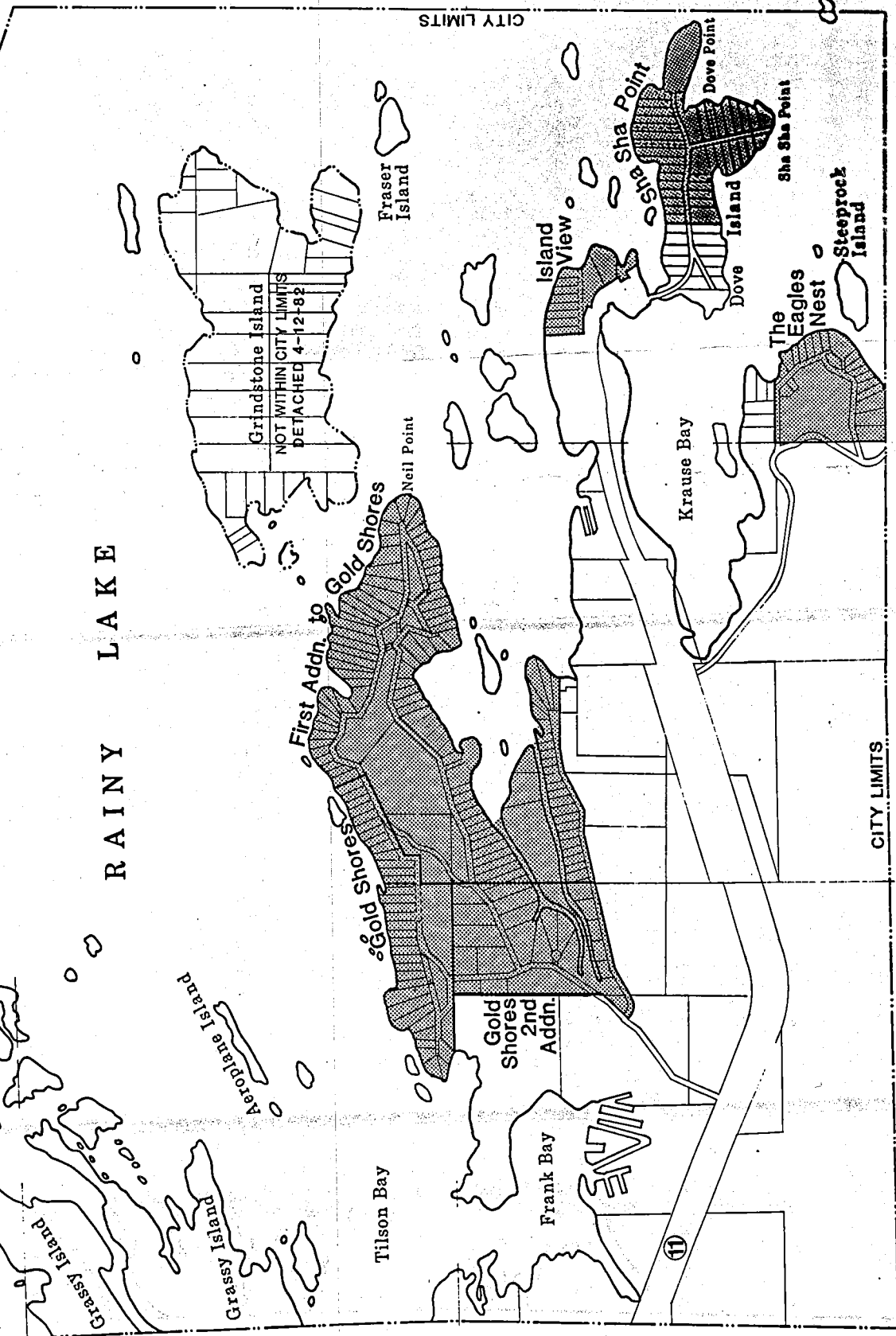
