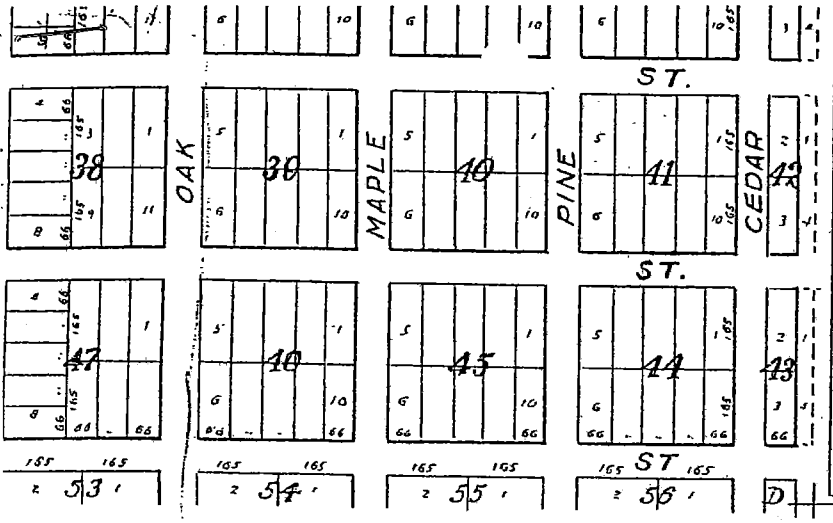

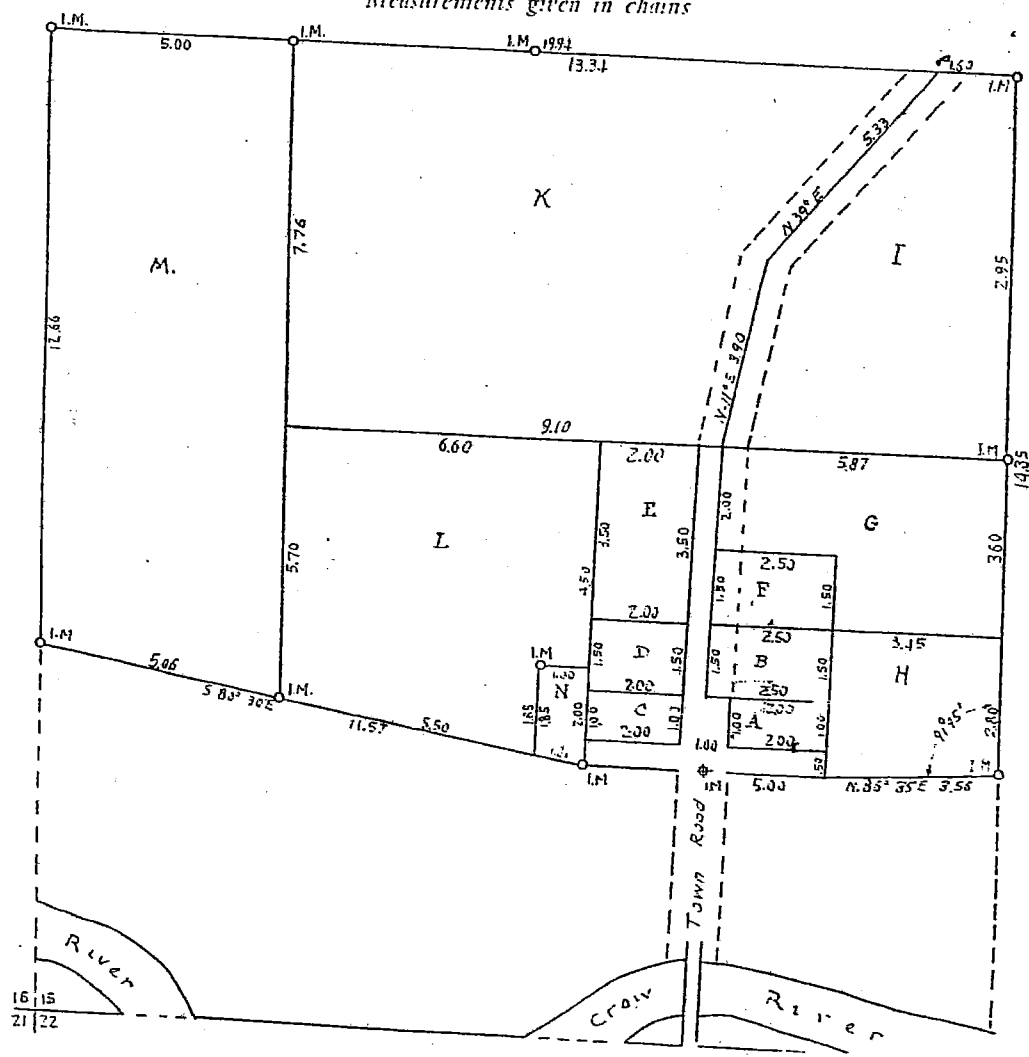

Section 15, Kingston Township

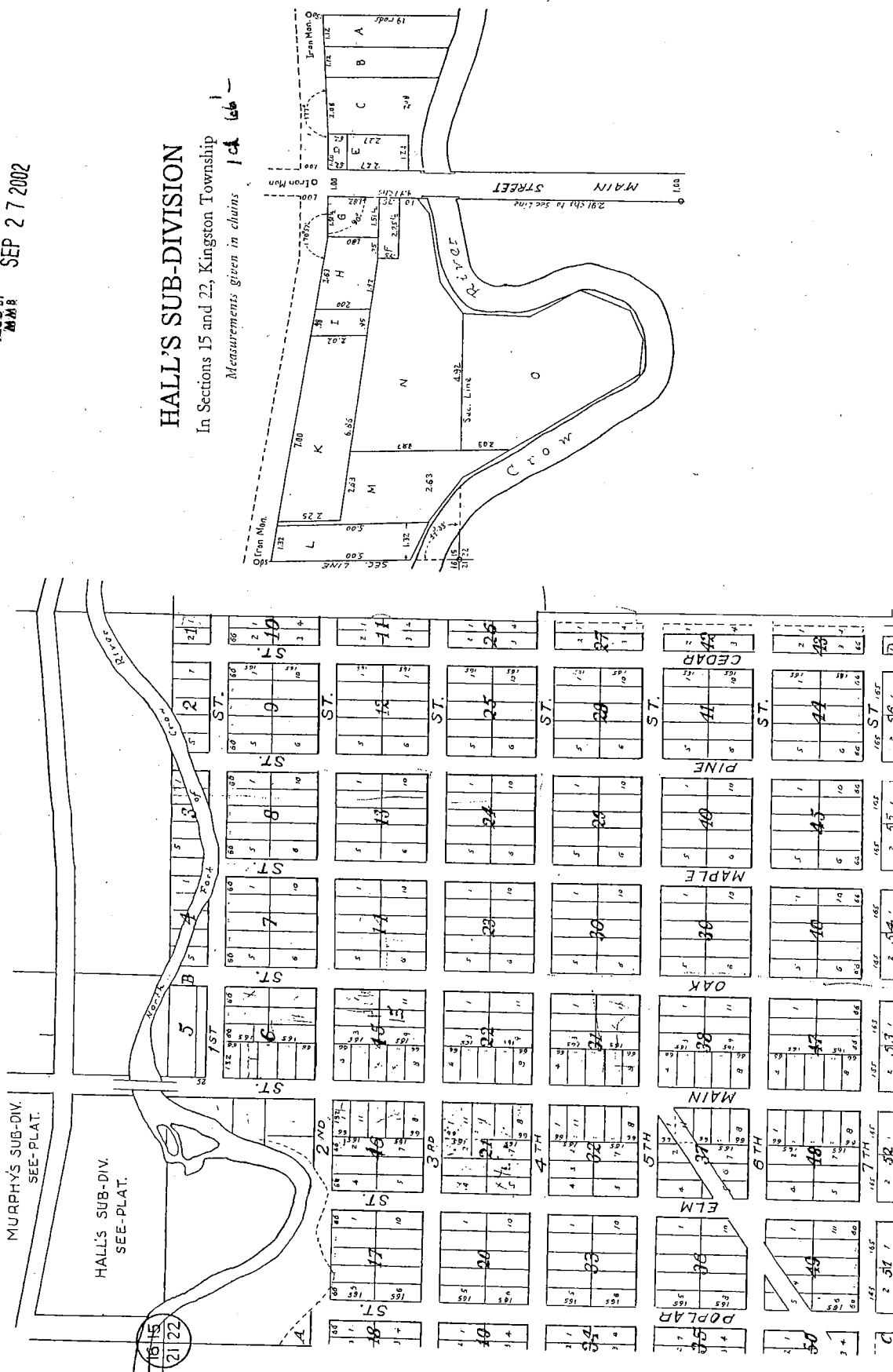

Scale 400 feet to 1 inch

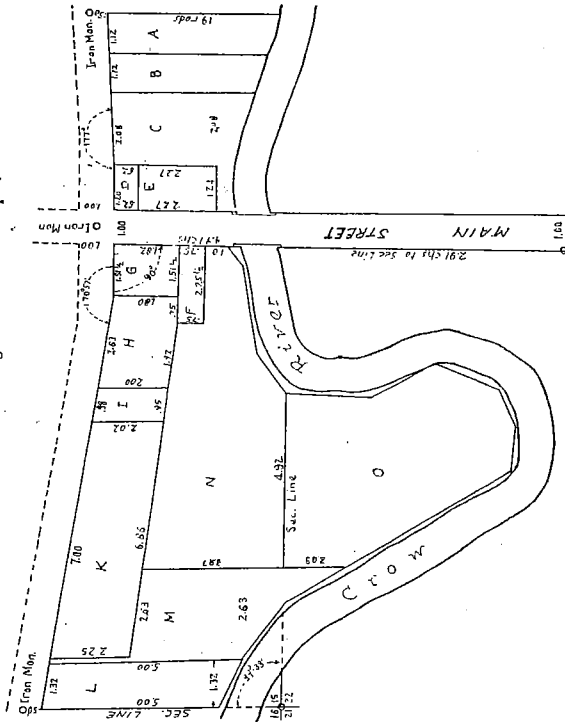

In Sections 15 and 22, Kingston Township

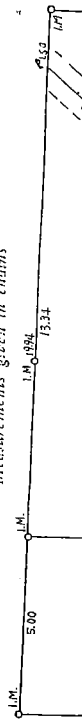

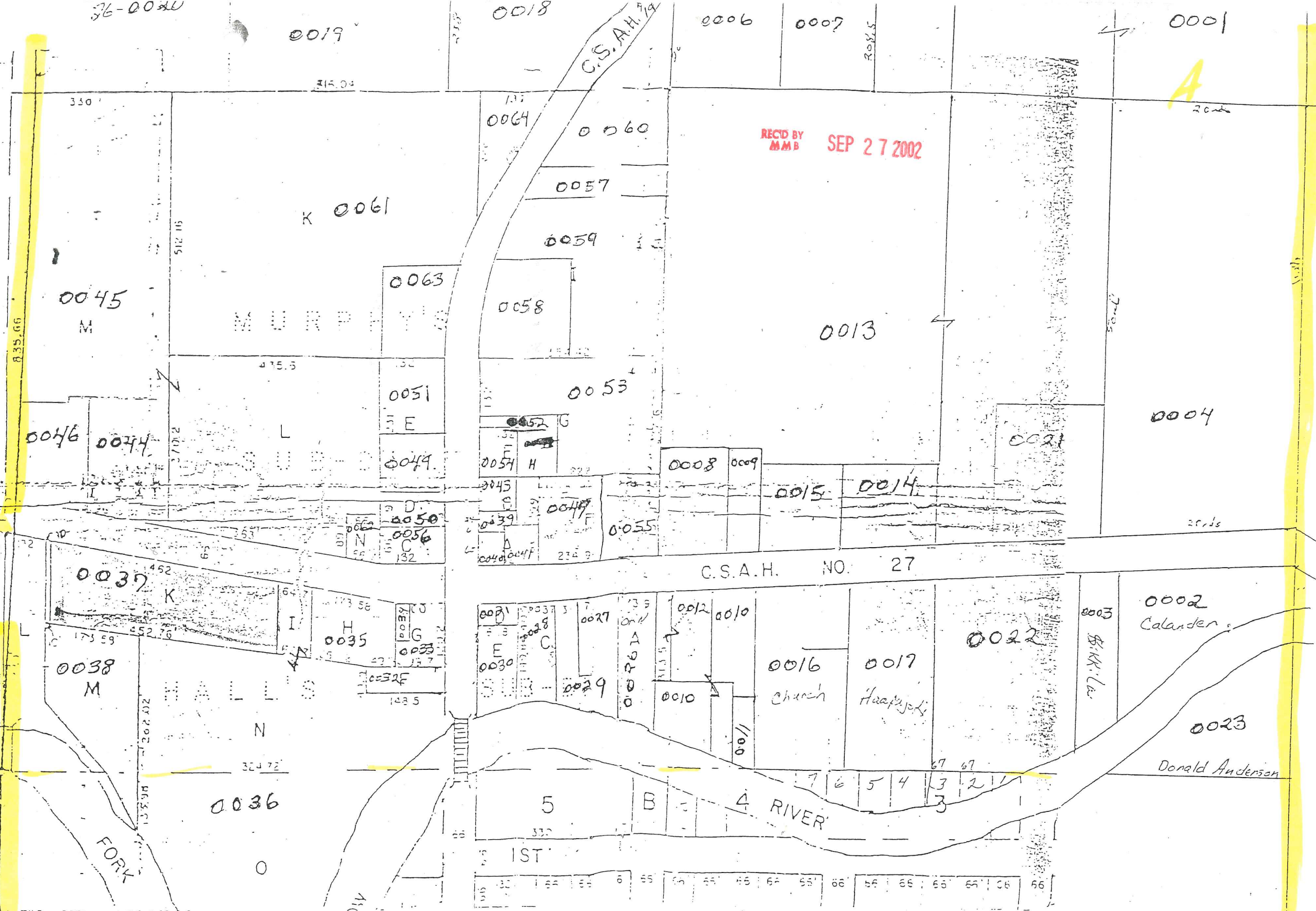
