Pursuant to Minnesota Statutes § 412.091, the undersigned petitioners hereby petition the Office of Administrative Hearings-Municipal Boundary Adjustments to call a special election on the question of dissolving the City of Ronneby, and state as follows:

1. 23 voters did vote in the last city election.
2. All persons signing this petition are voters duly qualified to vote in the city election for the City of Ronneby, and at least eight voters have signed this petition representing one-third of the voters voting at the 2006 city election as required by Minnesota Statutes § 412.091.
3. The property is surrounded by Maywood Township, Benton County.
4. The number of acres in this property proposed for dissolution is approximately 120-160 acres.
5. The territory proposed to be dissolved consists of all of the entire area lying within the boundaries of the City of Ronneby, Minnesota, all located in Sections 19 and 20, Township 37N, Range 28W, Benton County, Minnesota.
6. The dissolution is requested because these petitioners feel that there is no longer a need for the City to exist because the services provided by the City would more efficiently be provided by the Township and County.
7. The undersigned believe the City of Ronneby will become a part of Maynard Township within Benton County.
