7. The reasons that incorporation is being requested are as follows:
a. Under the present governments, road and street maintenance requirements are not being met to the satisfaction of the property owners of the area proposed for incorporation.

- b. Under the present governments, police protection is not as readily available as desired by the property owners of the area proposed for incorporation.
- c. The area proposed for incorporation is increasing in population to the extent that the present government are being taxed to cope with administrative requirements.
- d. The property owners of the area for proposed incorporation are not presently proportionately represented in the present governments and therefore do not receive what they feel are proportionate share of tax monies supported services as realized by residents in surrounding communities.
- e. The property owners in the proposed for incorporation have a higher assessed valuation of property, therefore pay higher taxes per capita yet have no unified voice in the expenditures of these local governments assets, or realize what they feel are fair share of tax supported services.
- f. The property owners in the area proposed for incorporation see the need for additional fire protection. Police, sewage disposal and water services in the future as the population increases yet have no assurance that these considerations are being planned for by present government and having no taxing authority are concerned for this need in the future.
- g. The property owners of the area proposed for incorporation feel that their administrative needs are becoming more of a suburban character and the existing form of government are not adequate to meet the public health, safety, and welfare of this expanding community.
- h. The local governments have not been able to coordinate their services and planning.

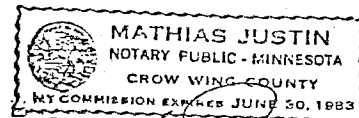
