**IN THE MATTER OF THE PETITION OF CERTAIN PERSONS
IN SPRING LAKE TOWNSHIP FOR INCORPORATION
PURSUANT TO MINNESOTA STATUTES SECTION 414.02**

WHEREAS, the undersigned Petitioners are property owners in Spring Lake Township; and

WHEREAS, the Township is presently not included within the limits of any incorporated municipality and includes land that has been platted into lots and blocks in the manner provided by law; and

WHEREAS, Minnesota Statutes section 414.02 provides the exclusive method of incorporating a municipality in Minnesota; and

WHEREAS, the 1990 U.S. Census reported the Township population at 2,853 residents and Scott County in 1995 estimated the Township population to be 3,353 residents; and

WHEREAS, the Township is now, or about to become, urban or suburban in character; and

WHEREAS, the existing Township form of government is not adequate to protect the public health, safety and welfare; and

WHEREAS, the Township has a certain assessed valuation, tax capacity, indebtedness, and other fiscal disclosures, all of which are listed on the attached Exhibit A; and

WHEREAS, the Municipality of Prior Lake is considering annexing a portion of the Township that is zoned for commercial/industrial development, which would otherwise be a source of revenues for the Township; and

WHEREAS, the Township recently approved a Comprehensive Plan, and Petitioners believe Incorporation would be the best way to implement that Plan; and

WHEREAS, Petitioners believe that Incorporation would be in the best interests of the Township;

THEREFORE, Petitioners formally request:

That the Minnesota Municipal Board institute a public hearing pursuant to Minnesota Statutes section 414.02 subdivision 2 and subsequent to said hearing, enter an order incorporating the Township as the City of Spring Lake pursuant to Minnesota Statutes section 414.02 subdivision 3;

That prior to the hearing on this matter that the Board notify all municipalities and townships abutting the Township and each planning agency which has jurisdiction over the affected area, all of which are listed on the attached Exhibit B;

That the final order of the Board set the boundaries of the City at the present Township Boundaries, which are indicated on the attached Exhibit C;

That the final order provide for election of Municipal Officers in accordance with Minnesota Statute section 414.09 subdivision 3.

EXHIBIT A

The total estimated market value of all Real and Personal Property in Spring Lake Township as of January 2, 1996, for taxes payable in 1997, is \$180,932,300. The adjusted net tax capacity is \$2,830,058.

There are 1,315 homestead parcels and 404 non-homestead parcels within Spring Lake Township; 505 parcels are zoned agricultural, 1,131 are zoned residential, 29 are zoned commercial, 9 are zoned industrial and 45 are zoned other.

The total bonded indebtedness of Spring Lake Township is \$129,000.
