

**IN THE MATTER OF THE PETITION OF HASSAN  
TOWNSHIP FOR INCORPORATION PURSUANT  
TO MINNESOTA STATUTE, SECTION 414.02**

The undersigned, being all of the Supervisors of Hassan Township hereby petition the Office of Strategic and Long Range Planning for incorporation pursuant to Minnesota Statute, Section 414.02.

Hassan Township is the sole remaining Township in Hennepin County with all of its neighboring communities in Hennepin County being statutory cities.

Hassan Township is suburban in character, much like its neighboring communities; Hassan enforces zoning and subdivision regulations and has existing residential, commercial and industrial plats of record.

The Town Board of Supervisors has determined that the township form of government does not adequately protect its citizens given its geographic location and the powers that the State grants to statutory cities. The Supervisors believe it to be in the best interest of the Township to seek incorporation.

That on October 7, 2002, the Hassan Town Board passed Resolution Number 10-01-02 entitled "A Resolution Approving Petition for Incorporation."

The proposed name of the incorporated municipality is







**A RESOLUTION APPROVING PETITION FOR INCORPORATION**

**WHEREAS**, Hassan Township is similar in size, population, development and geographic make-up as its municipal neighbors but its current form of government is unable to adequately protect the health, safety and welfare of its citizens; and

**WHEREAS**, the Hassan Town Board of Supervisors believes it to be in the best interest of its citizens to adopt the attached Petition for Incorporation and direct its delivery to the Director, of the Office of Strategic and Long Range Planning, for hearing pursuant to Minnesota Statute §414.02.

**NOW, THEREFORE**, the Hassan Town Board of Supervisors resolves to adopt the attached Petition for Incorporation and authorizes its Administrator to forward said Petition to the Director, of the Office of Strategic and Long Range Planning, forthwith.

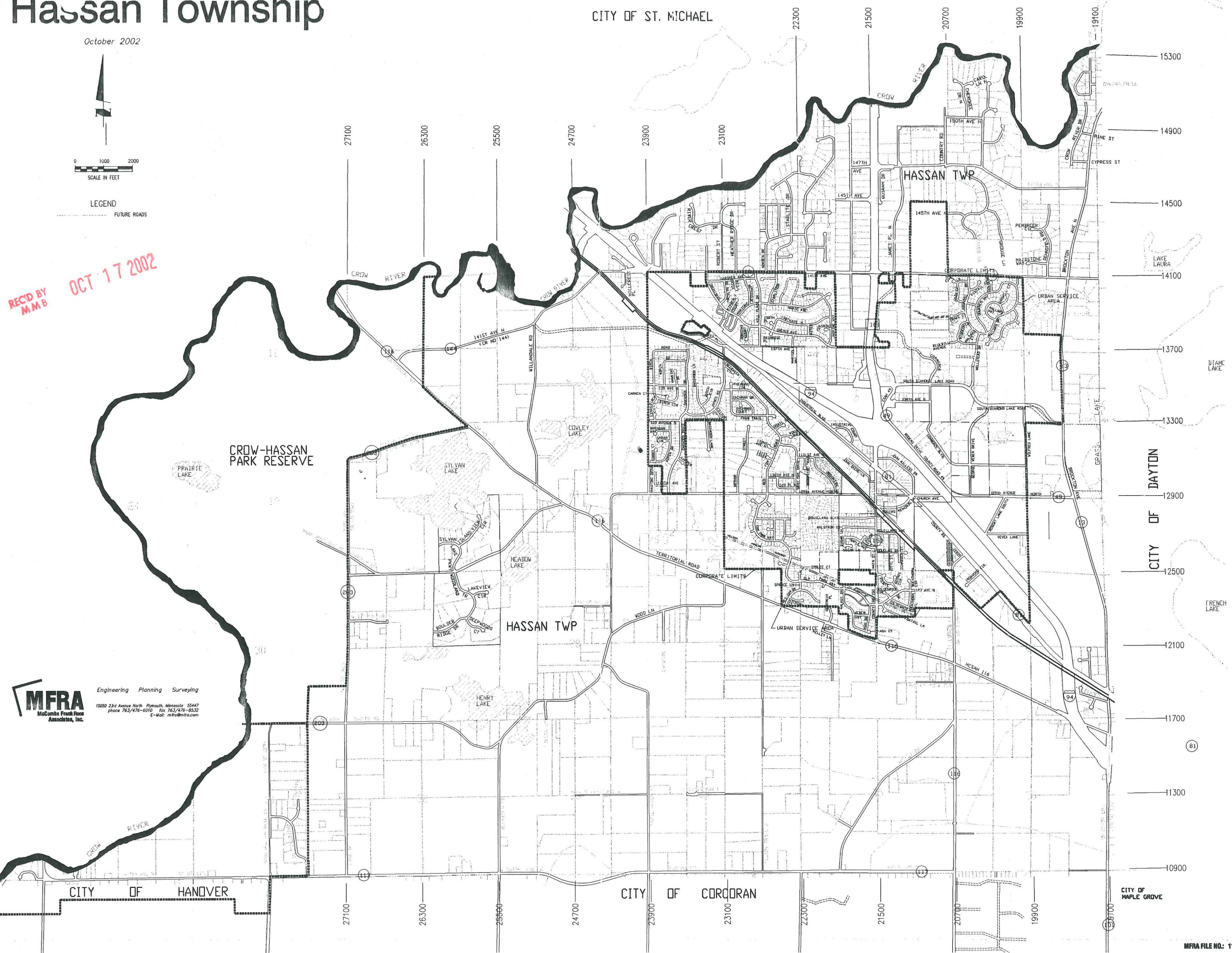

----- FUTURE ROADS

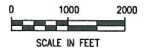
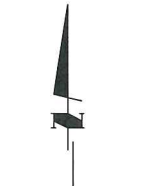

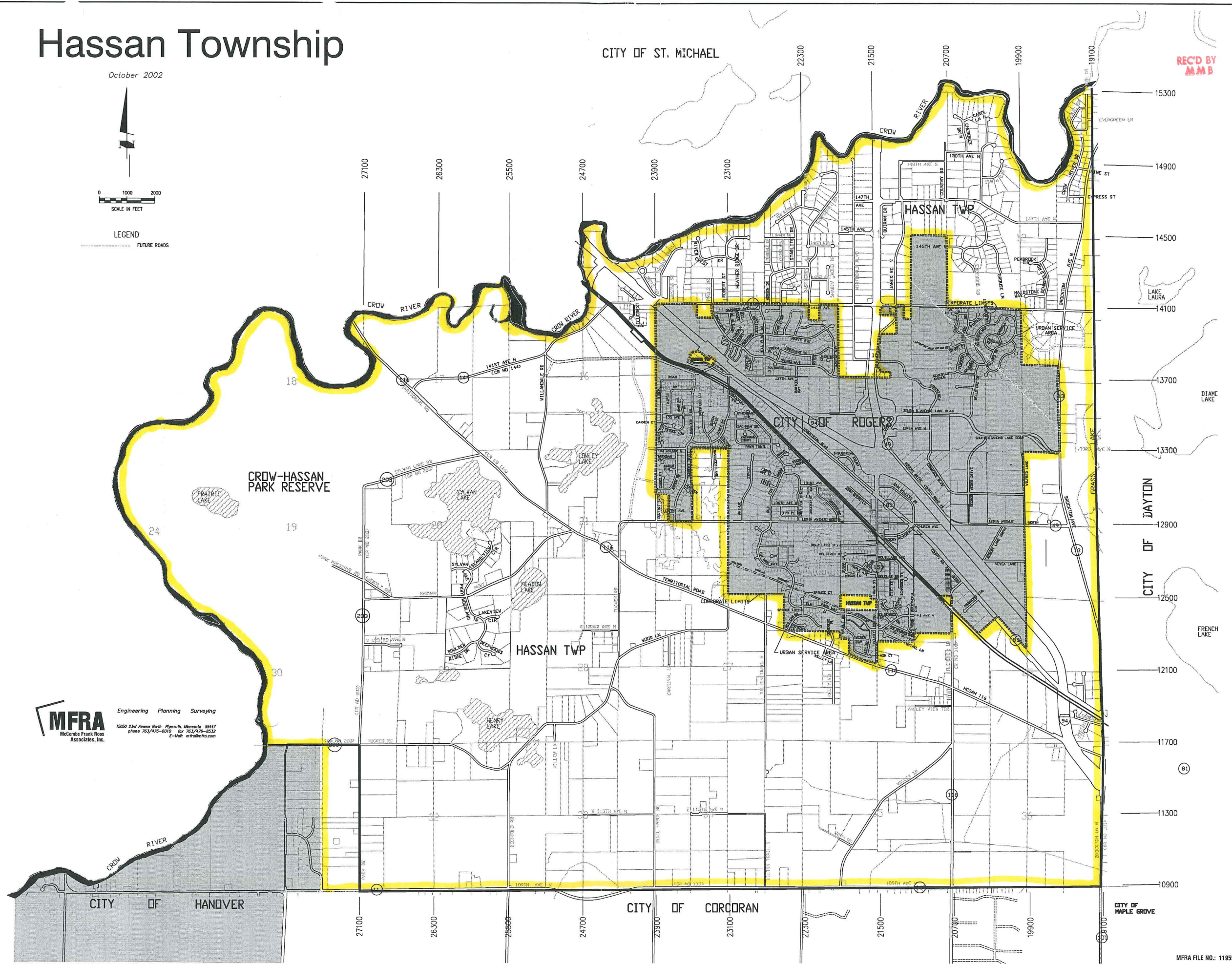
