AGREEMENT BETWEEN THE CITY OF LINDSTROM) ORDER
AND THE TOWN OF CHISAGO LAKE PURSUANT TO)
MINNESOTA STATUTES 414)

WHEREAS, a joint resolution for orderly annexation was adopted by the City of
Lindstrom and the Town of Chisago Lake; and

WHEREAS, a resolution was received from the City of Lindstrom indicating their desire
that certain property be annexed to the City of Lindstrom pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic
and Long Range Planning may review and comment, but shall within 30 days order the
annexation of land pursuant to said subdivisions; and

WHEREAS, on April 15, 2004, the Director has reviewed and accepted the resolution for
orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in
accordance with the terms of the joint resolution to the City of Lindstrom, Minnesota, the same
as if it had originally been made a part thereof:


That part of Government Lot 1, Section 4, Township 33 North, Range 20 West, Chisago
County, Minnesota, bounded on the east by the shoreline of south Center Lake, bounded
on the south by a line drawn parallel with and 150 feet northerly of, measured at right
angles to, the northerly line of the recorded plat of SANDEEN HEIGHTS, bounded in the
west by the easterly right-of-way line of Olinda Trail (also known as County State Aid

Highway No. 25), and bounded on the north by the following described line:

Commencing at the east quarter corner of said Section 4; thence South 89 degrees 46 minutes 27 seconds West, along east-west quarter line of said Section 4, a distance of 961.93 feet; thence at right angles South 0 degrees 13 minutes 33 seconds East, 1320.15 feet, more or less, to the north line of said government Lot 1; thence South 89 degrees 47 minutes 06 seconds West along the north line of said Government Lot 1, a distance of 405 feet, more or less, to the easterly right-of-way line of the County Road; thence southerly along said right-of-way line, 104.88 feet to the point of beginning of the line to be described; thence North 89 degrees 11 minutes East, 635 feet, more or less, to the waters edge of South Center Lake and said line there terminating.
