WHEREAS, a joint resolution for orderly annexation was adopted by the City of Zumbrota and the Town of Minneola; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Zumbrota pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivisions; and

WHEREAS, on July 8, 2004, the Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Zumbrota, Minnesota, the same as if it had originally been made a part thereof:

~~The East 660.00 feet of Outlot B, Sugar Loaf Estates, Goodhue County, Minnesota,~~

and the East 660.00 feet of Platted Sugar Loaf Parkway, according to the recorded Plat of Sugar Loaf Estates.

THE AMENDED DESCRIPTION READS AS FOLLOWS:

THE EAST 660.00 FEET OF OUTLOT B, SUGAR LOAF ESTATES, GOODHUE COUNTY, MINNESOTA, AND ALL THAT PART OF PLATTED SUGARLOAF PARKWAY LYING NORTHERLY OF AND ADJACENT TO SAID EAST 660.00 FEET OF OUTLOT B, ACCORDING TO THE RECORDED PLAT OF SUGAR LOAF ESTATES.


