MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Watertown and the Town of Watertown; and

WHEREAS, an amendment to the joint resolution was received from the City of Watertown and the Town of Watertown requesting that certain property be annexed to the City of Watertown pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on May 7, 1999, the Minnesota Municipal Board has reviewed and accepted the amendment to the joint resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Watertown, Minnesota, the same as if it had originally been made a part thereof:

Tract 1: That part of Outlot 25, Village of Watertown, according to the plat thereof on file and of record in the Office of the County Recorder, Carver

County, Minnesota, described as follows: Beginning at the Southeast corner of said Outlot 25, thence North 89 degrees 48 minutes 30 seconds West along the south line of said Outlot 25, a distance of 240.09 feet; thence North 0 degrees 06 minutes 50 seconds East, a distance of 218.16 feet; thence North 88 degrees 48 minutes 37 seconds East, a distance of 237.66 feet to the east line of said Outlot 25; thence South 0 degrees 31 minutes 21 seconds East along the east line of said Outlot 25, a distance of 223.90 feet to the point of beginning; Tract 2: Tract A, Registered Land Survey No. 24, files of Registrar of Titles; Tract 3: Tract B, Registered Land Survey No. 24, files of Registrar of Titles; Tract 4: Tract C, Registered Land Survey No. 24, files of Registrar of Titles; Tract 5: Tract D, Registered Land Survey No. 24, files of Registrar of Titles; Tract 6: Tract E, Registered Land Survey No. 24, files of Registrar of Titles; Tract 7: The south half of the south two acres of the east 13.8 acres of the north half of the southwest quarter of Section 9, Township 117, Range 25; Tract 8: South 522 feet of the north 709 feet of the west 835 feet of the Northwest Quarter (NW 1/4) of the Southeast Quarter (SE 1/4) of Section Nine (9), Township One Hundred Seventeen (117) North, Range Twenty-five (25) West of the 5th Principal Meridian.

IT IS FURTHER ORDERED: That the effective date of this order is May 7, 1999.
