WHEREAS, Reorganization Order No. 192, effective March 8, 2005, has transferred the duties of the Director to the Chief Administrative Law Judge; and

WHEREAS, on September 15, 2005, the Chief Administrative Law Judge has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Rochester, Minnesota, the same as if it had originally been made a part thereof:

The annexation area includes the right of way adjoining 19th Street NW:

All that part of Section 29, Township 107 North, Range 14 West, Olmsted County, Minnesota, lying within 60.00 feet north and 60.00 feet south (120.00 feet total width) of the following

described line:

Beginning at the Southwest corner of the Northwest Quarter of said Section 29, thence East along said the south line of the Northwest Quarter and the south line of the Northeast Quarter to the Southeast corner of the Northeast Quarter of said Section and there terminating.

Together

All that part of Section 30, Township 107 North, Range 14 West, Olmsted County, Minnesota, lying within 60.00 feet north and 60.00 feet south (120.00 feet total width) of the following described line:

Beginning at the Southeast corner of the Northeast Quarter of said Section 30, thence West along said the south line of the Northeast Quarter, 500 feet and there terminating.

Note: this annexation overlaps and clarifles previous annexations which have occurred overtime.
