WHEREAS, on June 28, 2001, the Director of the Office of Strategic and Long Range Planning has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the resolution to the City of Blue Earth,

Minnesota, the same as if it had originally been made a part thereof:

A tract of land in the East Half of the Northwest Quarter of Section 8, Township 102 North, Range 27 West in Faribault County, Minnesota described as follows:

Commencing at the Center of Scction 8, Township 102 North, Range 27 West in Faribault County, Minnesota, according to State Highway Right-of-way Plat No. 22-4, on file and of record in the office of the Faribault County Recorder, thence North 0 degrees 10 minutes 26 seconds West (grid bearing from Plat No. 22-4) along the East line of the Northwest Quarter a distance of 1170.85 feet to the point of beginning; thence continuing North 0 degrees 10 minutes 26 seconds West along the East line of the Northwest Quarter a distance of 1162.74 feet to the southerly highway right-of-way line of Interstate 90 according to said Plat No. 22-4; thence North 71 degrees 12 minutes 43 seconds West along said southerly highway right-of-way line a distance of 551.68 feet; thence South 0 degrees 10 minutes 26 seconds East a distance of 521.74 feet to the point of beginning.
