WHEREAS, a joint resolution for orderly annexation was adopted by the City of Eagle Bend and Wykeham Township; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Eagle Bend pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Chief Administrative Law Judge may review and comment, but shall within 30 days order the annexation pursuant to said subdivisions; and

WHEREAS, on May 15, 2008, the Chief Administrative Law Judge reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Eagle Bend, Minnesota, the same as if it had originally been made a part thereof:

That part of the West Half of the Northeast Quarter (W½ NE¼) of Section 14, Township 131 North, Range 35 West, Todd County, Minnesota described as follows:

Beginning at the southeast corner of said West Half of the Northeast Quarter (W½ NE¼);

thence North 89 degrees 13 minutes 12 seconds West, assumed bearing, along the

south line of said West Half of the Northeast Quarter (W½ NE¼) a distance of 244.70 feet to the center line of an existing public roadway;

thence North 41 degrees 12 minutes 56 seconds East, along said center line, 294.94 feet;

thence northeasterly, along said center line and along a tangential curve concave to the northwest, radius 260.00 feet, central angle 25 degrees 13 minutes 47 seconds, 114.49 feet to the east line of said West Half of the Northeast Quarter (W½ NE¾);

thence South 00 degrees 42 minutes 31 seconds West, along said east line, 324.93 feet to the point of beginning.

The tract contains 0.82 acres more or less subject to an existing public roadway easement over the northwesterly 33.00 feet thereof.

IT IS FURTHER ORDERED: That pursuant to Joint Resolution No. 08-01-423, signed by the City of Eagle Bend on April 21, 2008 and Wykeham Township on March 12, 2008, no reimbursement shall be made to the township pursuant to Minn. Stat. 414.036.
