AMENDMENT TO THE JOINT RESOLUTION BETWEEN THE TOWNSHIP OF YOUNG AMERICA, THE CITY OF NORWOOD AND THE CITY OF YOUNG AMERICA DESIGNATING AN AREA FOR ORDERLY ANNEXATION

Pursuant to M.S. 414.0325, Subdivision 1 the City of Norwood desires to immediately annex all parcels of property that have not previously been annexed to the City and which are located within the following described areas of the Township of Young America:

<u>Area One</u>

The North One-Half of the Northwest Quarter ($N\frac{1}{2}$ of $NW\frac{1}{4}$) of Section Fourteen (14), Township One Hundred Fifteen (115) North, Range Twenty-six (26) West, not within the existing corporate boundaries of the City of Young America;

and

<u>Area Two</u>

That part of the Northerly 400.4 feet of the South One-Half of the Southwest Quarter ($S_{\frac{1}{2}}$ of $SW_{\frac{1}{4}}$) of Section Fourteen (14), Township One Hundred Fifteen (115) North, Range Twenty-six (26) West, lying west of the Westerly ROW line of County Road 33;

and

Area Three

The Northerly 400.4 feet of the Easterly 141 feet of the Southeast Quarter of the Southeast Quarter ($SE^{\frac{1}{4}}$ of $SE^{\frac{1}{4}}$) of Section Fifteen (15), Township One Hundred Fifteen (115), Range Twenty-six (26) West;

and

Area Four

That part of the Northeast Quarter ($NE_{\frac{1}{4}}$) of Section Fifteen (15), Township One Hundred Fifteen (115) North, Range Twenty-six (26) West lying South of the centerline of Trunk Highway 212.

WHEREAS, each of the above-described areas fall entirely within the City of Norwood's orderly annexation area as created and described by the Joint Resolution which was adopted by the Township of Young America, the City of Norwood and the City of Young America in February of 1982 and duly approved by the Minnesota Municipal Board on March 12, 1982, as subsequently amended; and

WHEREAS, the City of Norwood deems that the previously unannexed parcels located within the above-described areas are now or are about to become urban

or suburban in character, that annexation of said parcels would be in the best interests of the City of Norwood, that annexation would be in the best interest of the parcels proposed for annexation, and that all of the requirements for annexation under the terms of said Joint Resolution have been satisfied; and

WHEREAS, the Township of Young America, the City of Norwood and the City of Young America agree that no alteration of the stated boundaries of this agreement is appropriate and furthermore that no consideration by the Municipal Board is necessary,

NOW THEREFORE, IT IS HEREBY RESOLVED that upon receipt of this resolution, the Municipal Board may review and comment, but shall within 30 days order the annexation of all parcels located within the above-described areas which have not been previously annexed to the City of Norwood, in accordance with the terms of the signatories' Joint Resolution dated March 12, 1982, as amended, and pursuant to the provisions of Minnesota Statute §414.0325.

This amendment is to take full force and effect upon the date of filing of the Minnesota Municipal Board's order approving the same.
