JOINT RESOLUTION OF THE CITY OF NORWOOD YOUNG AMERICA AND THE TOWNSHIP OF YOUNG AMERICA FOR ANNEXATION OF CERTAIN PROPERTY WITHIN THE TOWNSHIP OF YOUNG AMERICA

Pursuant to Minnesota Statute 414.0325, Subd. 1, the City of Norwood Young America desires to annex certain property within the Township of Young America (Township), legally described as follows:

See attached Exhibit A.

WHEREAS, said property falls entirely within the City's orderly annexation area as originally created and described by the joint resolution, as subsequently amended, which was adopted by the Township and the now consolidated Cities of Norwood and Young America in February of 1982 and which was duly approved by the Minnesota Municipal Board on March 12, 1982;

WHEREAS, a petition for annexation signed by each of the property owners of the above-described parcel of land has been presented to and received by the City;

WHEREAS, said land to be annexed is or is about to become urban or suburban in character; that annexation of said property would be both in the best interests of the City and of the property proposed for annexation; that the City is capable of providing the area proposed for annexation with all of the services it presently provides its current residents; and that all of the requirements for annexation under the terms of said joint resolution, as amended, have been satisfied;


WHEREAS, the Township and City agree that no alteration of the stated boundaries of the property proposed for annexation is appropriate and that no consideration by the Office of Strategic and Long Range Planning (Minnesota Planning) is necessary;
