AMENDED ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Marshall and the Town of Lake Marshall; and

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Marshall, Minnesota, the same as if it had originally been made a part thereof:

ALL THAT PART OF THE E1/2 OF THE SW1/4 OF SECTION 9, T111N, R41W EXCEPTING THE N124' THEREOF, DESCRIBED AS FOLLOWS:

Commencing at the SE corner of the NW 1/4 of Section 9, T111N, R41W, thence S0°24'32"E assumed bearing a distance of 124 feet to point of beginning; thence

S0°24'32"E a distance of 2533.27 feet; thence S89°57'48"E a distance of 1344.61 feet to the SE corner of the SW 1/4 Section 9; thence N0°41'45"W a distance of 2530.94 feet; thence N89°51'26"W a distance of 1331.94 feet to point of beginning; said area containing 77.79 acres more or less.
