IN THE MATTER OF THE ORDERLY ANNEXATION BETWEEN THE CITY OF OLIVIA AND BIRD ISLAND TOWNSHIP PURSUANT TO MINNESOTA STATUTES § 414.0325

WHEREAS, a request from all of the property owners of the area proposed for designation and immediate annexation was received.

WHEREAS, the City of Olivia ("City") and Bird Island Township ("Township") jointly agree to designate and request the immediate annexation of the following described land located within Bird Island Township to the City of Olivia, County of Renville, Minnesota;

WHEREAS, the City and Township are in agreement as to the orderly annexation of the unincorporated land described; and

WHEREAS, Minnesota Statutes § 414.0325 provides a procedure whereby the City and Township may agree on a process of orderly annexation of a designated area; and

WHEREAS, the City and Township have agreed to all the terms and conditions for the annexation of the above-described lands; and the signatories hereto agree that no alteration of the designated area is appropriate and no consideration by the Chief Administrative Law Judge is necessary. The Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation in accordance with the terms of the resolution.

NOW, THEREFORE, BE IT RESOLVED, jointly by the City Council of the City of Olivia and the Township Board of Bird Island Township as follows:

1. (Property.) That the following described land also identified on the area map included as Exhibit A of this resolution is subject to orderly annexation pursuant to Minnesota Statutes § 414.0325, and that the parties hereto designate the area for orderly annexation; and agree that the land be immediately annexed:

1. Pheasant Lawn Residential Lot Extensions

That part of the Northwest Quarter of the Southeast Quarter of Section 18, Township 115 North, Range 34 West of the Fifth Principal Meridian, Bird Island Township, Renville County, Minnesota, described as follows;

- Commencing at the southwest corner of the Southeast Quarter of said Section 18;
- thence on a geodetic bearing of North 00 degrees 06 minutes 50 seconds West, along the west line of the Southeast Quarter of said Section 18, a distance of 2335.67 feet to to the south line of the north 313.50 feet of the Northwest Quarter of the Southeast Quarter of said Section 18, which is the point of beginning of the land to be described;
- thence on a bearing of South 89 degrees 00 minutes 34 seconds East, along the south line of the north 313.50 feet of the Northwest Quarter of the Southeast Quarter of said Section 18, a distance of 1322.39 feet to the east line of the Northwest Quarter of the Southeast Quarter of said Section 18;

2. (Acreage/Population/Usage.) That the orderly annexation area consists of approximately 11.77 acres, the population in the area is 0, and the land use type is Residential and Institutional.

3. (Jurisdiction.) That Bird Island Township and the City of Olivia, by submission of this joint resolution to the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, confers jurisdiction upon the Chief Administrative Law Judge so as to accomplish said orderly annexation in accordance with the terms of this resolution.

4. (Municipal Reimbursement). Minnesota Statutes § 414.036. a. Reimbursement to Towns for lost taxes on annexed property.

The Parties agree to a one-time reimbursement payment of \$100.00

5. (Review and Comment). The City and Township agree that upon receipt of this resolution, passed and adopted by each party, the Chief Administrative Law Judge may review and comment, but shall within thirty (30) days, order the annexation in accordance with the terms of the resolution.
