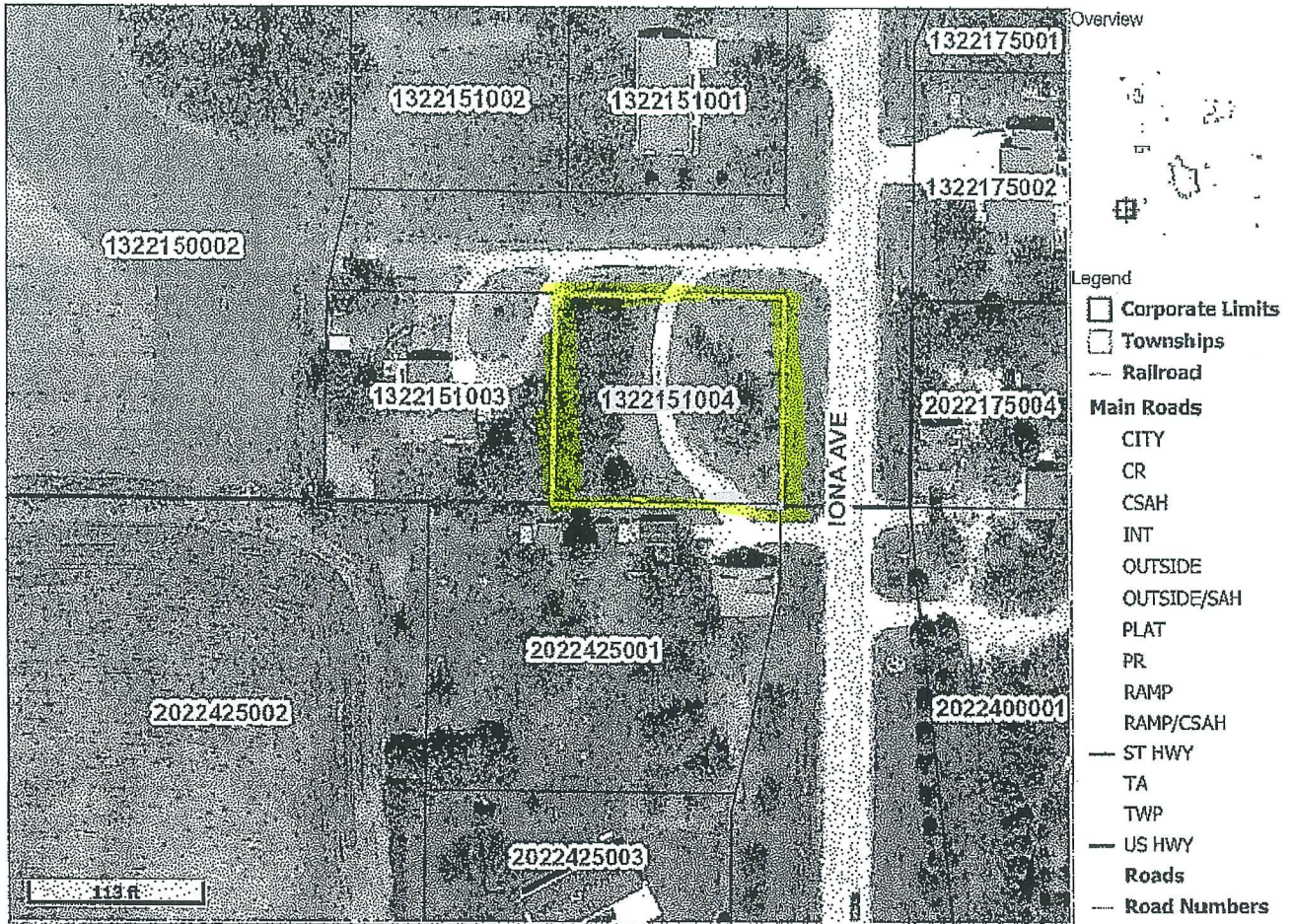

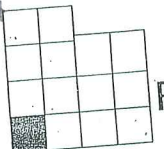

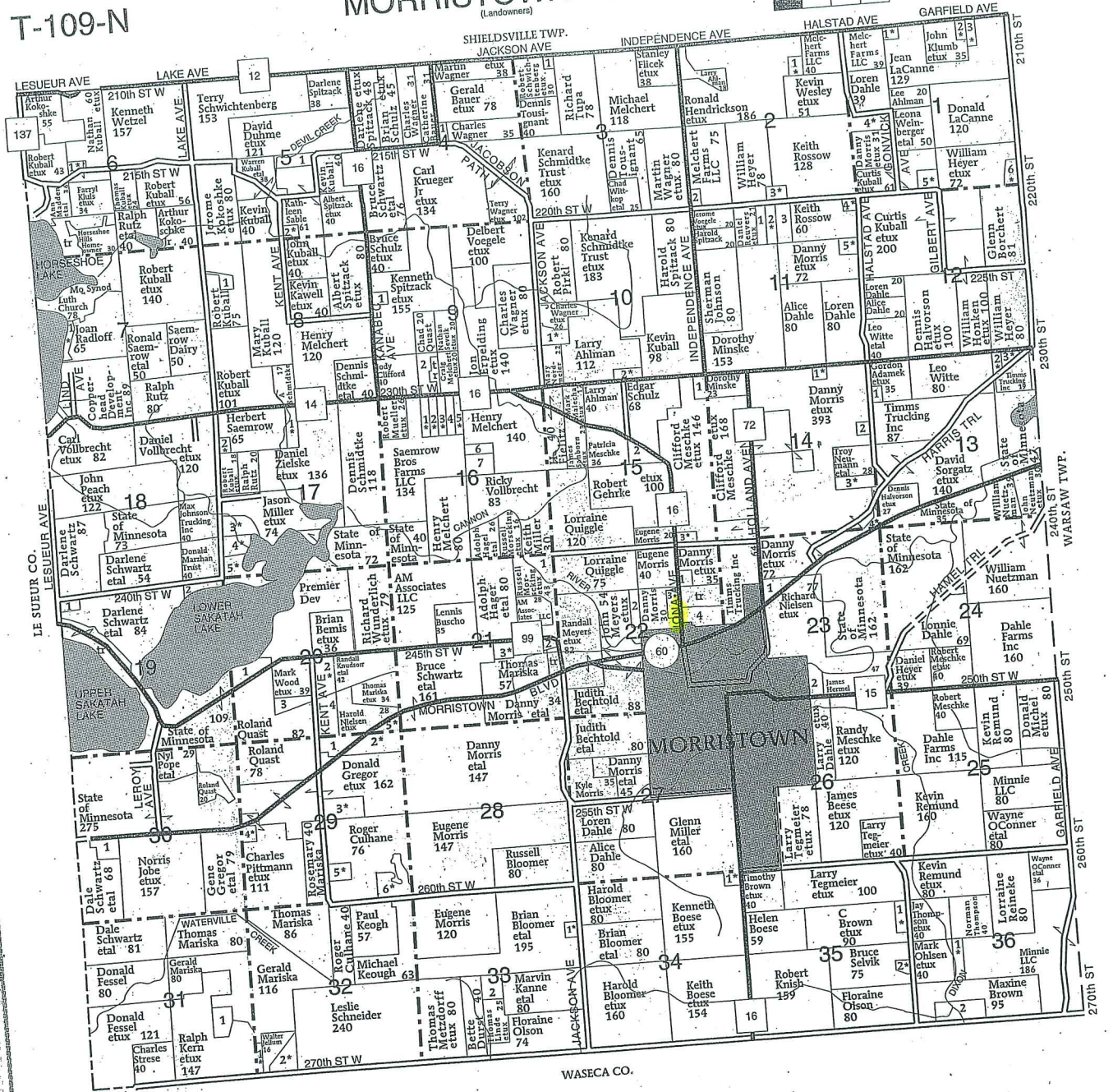


MORRISTOWN PLAT
