WHEREAS, a joint resolution for orderly annexation was adopted by the City of Delano and the Town of Franklin and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be immediately annexed to the City of Delano pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 requires that the Minnesota Municipal Board review and comment, but within 30 days approve the annexation of land pursuant to said subdivision; and

WHEREAS, on February 17, 1987, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

WHEREAS, the joint resolution received on February 6, 1987 failed to describe the area proposed for annexation between the parties; and

WHEREAS, the City of Delano and the Town of Franklin adopted an amended resolution received on April 15, 1987 with a corrected property description; and WHEREAS, the Minnesota Municipal Board has reviewed and accepted the

amendment to the orderly annexation joint agreement; and

WHEREAS, the error in the original property description voided the annexation of the land described in the February 17, 1987 order,

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Delano, Minnesota, the same as if it had originally been made a part thereof:

MEMORANDUM

On February 6, 1987 the Municipal Board received a Joint Resolution Between the Town of Franklin and the City of Delano Designating an Area for Orderly Annexation and requesting annexation. The Municipal Board issued an order annexing said area on February 17, 1986. The joint resolution, through clerical error, contained an inaccurate property description of an area not abutting the city and not intended for annexation. It also included land already within the city. The parcel intended to be annexed was not described in the original joint resolution. An amendment to the joint resolution was passed by the city and town to delete the original property description and substitute the description of the property which the town and city had intended to annex. The Municipal Board now amends it's order to annex the property which the Town of Franklin and the City of Delano agreed upon.
