**ORDER AMENDING THE
ORDER APPROVING ANNEXATION**

On June 5, 2018, an Order Approving Annexation was issued for the annexation of certain real property to the City of Shakopee (City) from Jackson Township (Township) pursuant to Minn. Stat. § 414.0325 (2016).

On June 25, 2018, the City contacted the Office of Administrative Hearings to advise that the legal description in the June 5, 2018 Order Approving Annexation contained a typographical error.

Based upon a review of the proceeding, the Chief Administrative Law Judge makes the following:

ORDER

1. The legal description in the June 5, 2018 Order Approving Annexation is **amended** to read as follows:

That part of the Southwest Quarter of the Northwest Quarter and the Northwest Quarter of the Southwest Quarter of Section 13, Township 115, Range 23, Scott County, Minnesota described as follows:

Beginning at the Southwest corner of said Southwest Quarter of the Northwest Quarter; thence on an assumed bearing of North 01 degrees 22 minutes 16 seconds West, along the West line of said Southwest Quarter of the Northwest Quarter a distance of 130.82 feet; thence North 88 degrees 37 minutes 44 seconds East a distance of 1332.46 feet to the east line of said Southwest Quarter of the Northwest Quarter; thence South 00 degrees 44 minutes 43 seconds East along said east line a distance of 257.21 feet to the **Southeast** corner of said Southwest Quarter of the Northwest Quarter; thence South 00 degrees 06 minutes 47 seconds East along the east line of the Northwest Quarter of the Southwest Quarter of said Section 13 a distance of 69.85 feet; thence South 88 degrees 37 minutes 44 seconds West a distance of 1332.80 feet to a point on the West line of said Northwest Quarter of the Southwest Quarter distant 196.26 feet south from

the Southwest corner of said Southwest Quarter of the Northwest Quarter; thence North 00 degrees 00 minutes 16 seconds West along said west line a distance of 196.26 feet to the point of beginning. Containing 10.00 acres.
