IN THE MATTER OF THE ORDERLY ANNEXATION) A M E N D E D
AGREEMENT BETWEEN THE CITY OF SAUK RAPIDS) ORDER
AND THE TOWN OF SAUK RAPIDS PURSUANT TO)
MINNESOTA STATUTES 414))

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Sauk Rapids and the Town of Sauk Rapids; and

WHEREAS, a resolution was received from the City of Sauk Rapids indicating their desire that certain property be annexed to the City of Sauk Rapids pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on April 7, 1995, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Sauk Rapids, Minnesota, the same as if it had originally been made a part thereof:

That part of the West Half of the Southeast Quarter and that part of the Southwest Quarter of the ~~Northwest~~ ^{Northeast} Quarter of Section 14, Township 36 North, Range 31 West of the 4th Principal Meridian, Benton County, Minnesota described as follows:

Commencing at the southwest corner of said West Quarter of the Southeast Quarter; thence North 00 degrees 21 minutes 12 seconds East, along the west line of said Southeast Quarter, a distance of 2,496.84 feet, to the point of beginning of the land to be described:

Thence continue North 00 degrees 21 minutes 12 seconds East,

along said west line of the Southeast Quarter and along the
Northeast
west line of the said Southwest Quarter of the ~~Northwest~~
Quarter, to the southwesterly line of MINNESOTA DEPARTMENT OF
TRANSPORTATION RIGHT-OF-WAY PLAT NO. 05-12, according to the
recorded plat thereof; thence southeasterly, along the said
southwesterly line, to monument B1220 of said MINNESOTA
DEPARTMENT OF TRANSPORTATION RIGHT-OF-WAY PLAT NO. 05-12;
thence South 37 degrees 11 minutes 13 seconds East, along the
southwesterly right-of-way line of U.S. Highway 10, a distance
of 1,036.95 feet; thence South 52 degrees 48 minutes 47
seconds West, a distance of 300.00 feet; thence South 37
degrees 11 minutes 13 seconds East, a distance of 145.00 feet;
thence North 52 degrees 48 minutes 47 seconds East, a distance
of 300.00 feet, to the said southwesterly right-of-way line;
thence South 37 degrees 11 minutes 13 seconds East, along said
southwesterly right-of-way line, to the east line of the said
West Half of the Southeast Quarter; thence South 00 degrees 07
minutes 05 seconds East, along said east line of the West Half
of the Southeast Quarter, a distance of 808.41 feet; thence
North 89 degrees 23 minutes 28 seconds West, a distance of
33.00 feet; thence North 00 degrees 07 minutes 05 seconds
West, a distance of 203.63 feet; thence northwesterly 194.09
feet, along a tangential curve, concave to the west, having a
radius of 300.00 feet, and a central angle of 37 degrees 04
minutes 08 seconds; thence North 37 degrees 11 minutes 13
seconds West, tangent to said curve, a distance of 44.87 feet;
thence South 58 degrees 55 minutes 27 seconds West, a distance
of 140.80 feet; thence North 37 degrees 11 minutes 13 seconds
West, a distance of 1,515.07 feet; thence North 40 degrees 48
minutes 16 seconds West, a distance of 55.23 feet; thence
North 63 degrees 12 minutes 10 seconds West, a distance of
47.59 feet; thence North 84 degrees 28 minutes 03 seconds
West, a distance of 59.44 feet; thence South 89 degrees 38
minutes 48 seconds West, a distance of 40.00 feet, to the
point of beginning.

Also, the northeasterly 40.00 feet of Lot 5 and 6, Block One,
WHITNEY OAKES PLAT THREE, according to the recorded plat
thereof. Less area previously annexed into the City of Sauk
Rapids.


That the quantity of land described above is approximately

order is May 8, 1995.


