

RESOLUTION NO. 96-14

A RESOLUTION ANNEXING APPROXIMATELY 905 FEET OF
SUMMIT AVENUE NORTH RIGHT OF WAY

WHEREAS, the City of Sauk Rapids has requested the annexation of approximately 905 feet of Summit Avenue North right of way not previously annexed, and

WHEREAS, the Township Board has been notified and the City Council understands the Town agrees to the annexation, and

WHEREAS, the roadway lies with an Orderly Annexation area and is subject to annexation by resolution,

NOW THEREFORE BE IT RESOLVED BY THE SAUK RAPIDS CITY COUNCIL THAT:

1. That the following described property is hereby annexed:

The east 33.00 feet of the West One Half of the Southeast Quarter of Section 14, Township 36 North, Range 31 West, Benton County, Minnesota lying south of the south line of the North 422.50 feet of the Southwest Quarter of the Southeast Quarter, Section 14, Township 36 North, Range 31 West, Benton County, Minnesota. Said annexation is also part of the Southwest Quarter of the Southeast Quarter (SW1/4 SE1/4) of Section 14.

2. That the quantity of land described above is approximately 0.66 acres.
3. In accord with MSA414.0325 and the Orderly Annexation Agreement the Minnesota Municipal Board is asked to order the annexation.
