WHEREAS, a public hearing was held November 10, 1997 and continued to this date at which time all persons desiring to be heard were given an opportunity, and


WHEREAS, the Sauk Rapids Joint Planning Board, and the Sauk Rapids Planning Commission have reviewed and recommended the annexation, and

NOW THEREFORE BE IT RESOLVED BY THE SAUK RAPIDS CITY COUNCIL THAT:


- 1. That Lot 5, Block 1, Hi-Acres is hereby annexed.

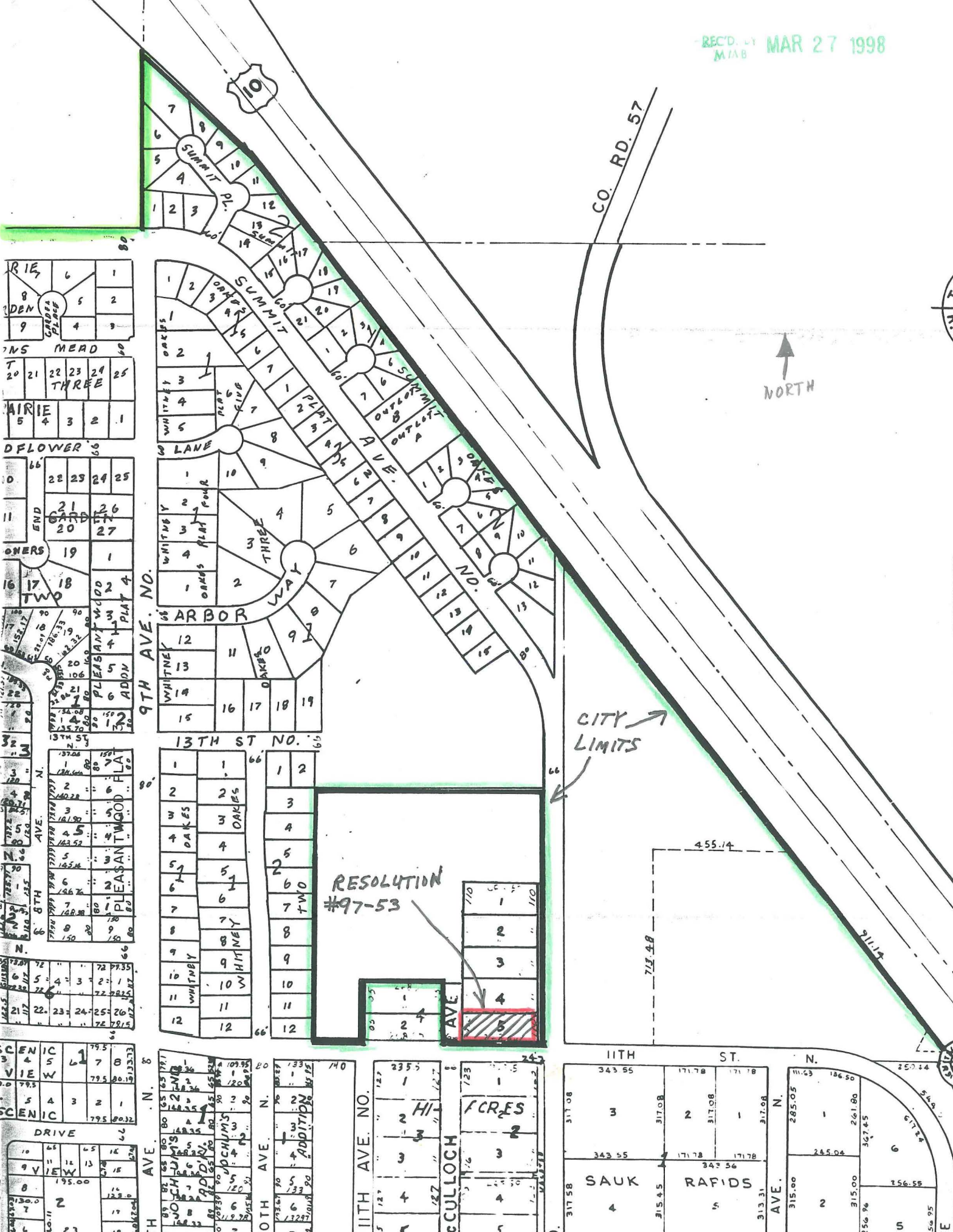
