RESOLUTION OF THE TOWN OF
FOREST PRAIRIE AND THE CITY
OF WATKINS DESIGNATING AN
UNINCORPORATED AREA AS IN
NEED OF ORDERLY ANNEXATION
AND CONFERRING JURISDICTION
OVER SAID AREA TO THE
MINNESOTA MUNICIPAL BOARD
PURSUANT TO M.S. 414.0325.

JOINT RESOLUTION
FOR ORDERLY
ANNEXATION

The Township of Forest Prairie and the City of Watkins hereby jointly agree to the following:

1. That the following described area in Forest Prairie Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to-wit:

That part of the West half of the Southwest Quarter (W 1/2 of SW 1/4) as described in book 464, page 157 at the Office of the Meeker County Recorder, of Section One (1), Township One Hundred Twenty-One North (121N), Range Thirty (30). Consisting of approximately 12.27 acres more or less.

2. That the Town Board of the Township of Forest Prairie and the City Council of the City of Watkins, upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in the agreement.
3. That these certain properties which about the City of Watkins is presently urban or suburban in nature or are about to become so. Further, the City of Watkins is capable of providing services to this area within a reasonable time, and the annexation is in the best interests of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Watkins to-wit:

That part of the West half of the Southwest Quarter (W 1/2 of SW 1/4) as described in book 464, page 157 at the Office of the Meeker County Recorder, of Section One (1), Township One Hundred Twenty-One North (121N), Range Thirty (30). Consisting of approximately 12.27 acres more or less.

4. Both the Town of Forest Prairie and the City of Watkins agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.

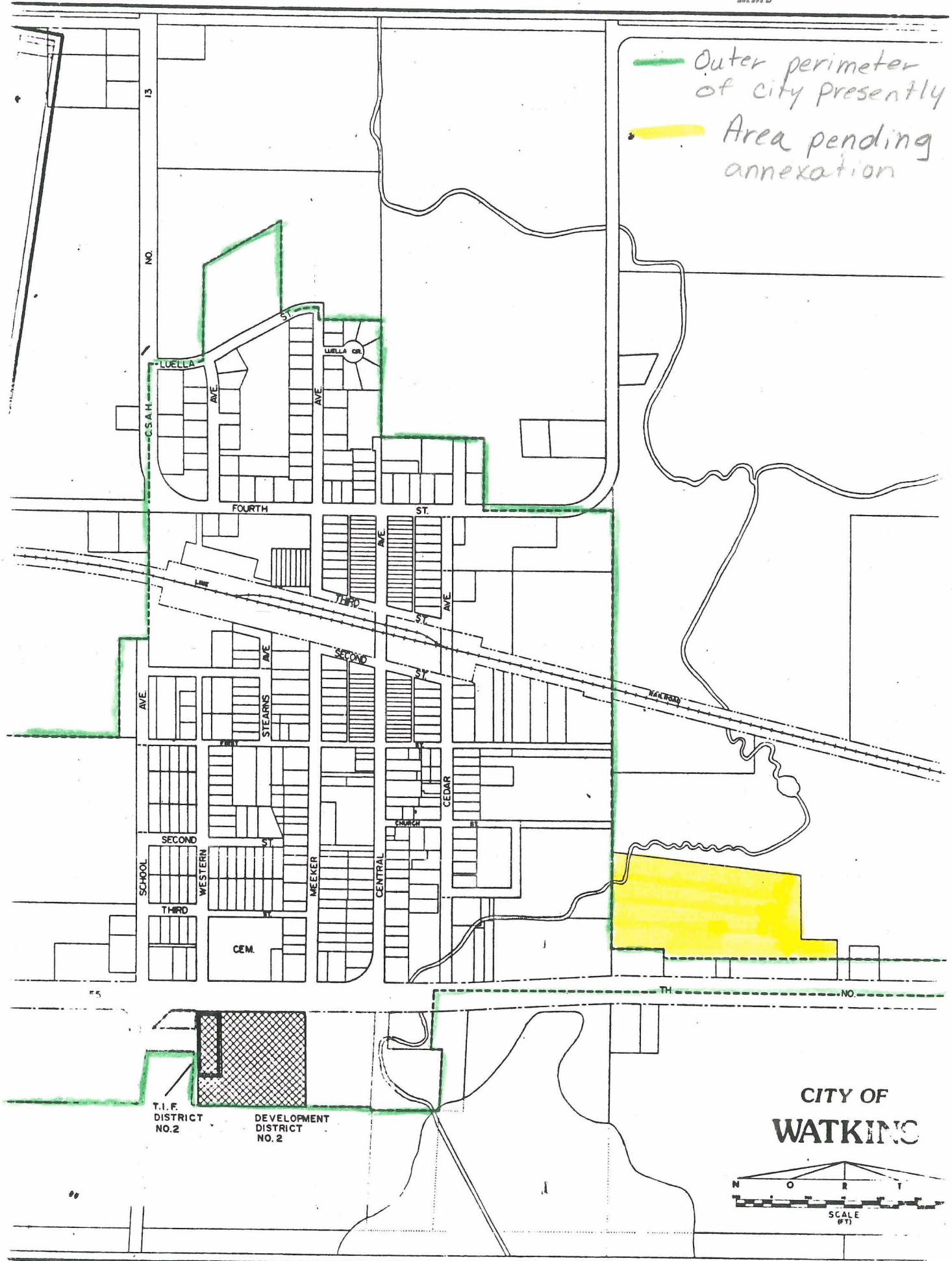
