AND CONFERRING JURISDICTION
OVER SAID AREA TO THE MINNESOTA
MUNICIPAL BOARD PURSUANT TO
M.S. 414.0325

JOINT RESOLUTION
FOR ORDERLY ANNEXATION

The Township of Aitkin and the City of Aitkin hereby jointly agree
to the following:

1. That the following described area in Aitkin Township is
subject to orderly annexation pursuant to Minnesota Statutes 414.
0325, and the parties hereto designate this area for orderly annexa-
tion, to-wit:

That part of Aitkin Township Road No. T-129 lying northerly
of a line that bears North 89 degrees 06 minutes 30 seconds
East from the southeast corner of said Lot 2, Block One,
Shady Oaks, Aitkin County, Minnesota. For the purpose of
this description the east line of said Lot 2 has an assigned
bearing of North 00 degrees 53 minutes 30 seconds West.

2. That the Town Board of the Township of Aitkin and the City
Council of the City of Aitkin, upon passage and adoption of this
resolution and upon the acceptance by the Municipal Board, confer
jurisdiction upon the Municipal Board over the various provisions
contained in the agreement.

3. That this certain property which abbutts the City of Aitkin
is presently urban or suburban in nature and is about to become so.

Further, the City of Aitkin is capable of providing services to this area within a reasonable time, and the annexation is in the best interests of the area proposed for annexation. Therefore, this property would be immediately annexed to the City of Aitkin, to-wit:

That part of Aitkin Township Road No. T-129 lying northerly of a line that bears North 89 degrees 06 minutes 30 seconds East from the Southeast corner of said Lot 2, Block One, Shady Oaks, Aitkin County, Minnesota. For the purpose of this description the east line of said Lot 2 had an assigned bearing of North 00 degrees 53 minutes 30 seconds West.

4. Both the Town of Aitkin and the City of Aitkin agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.

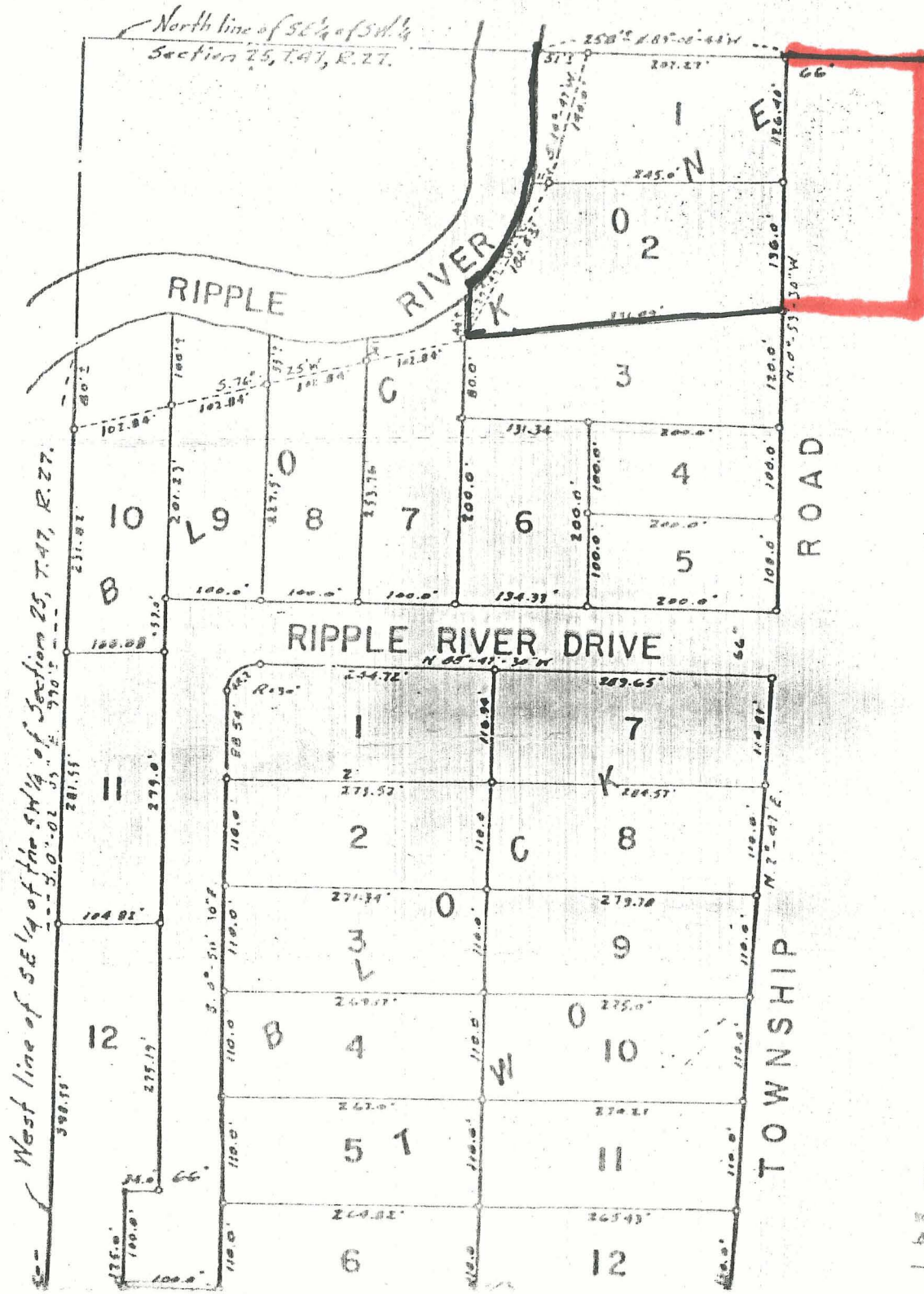

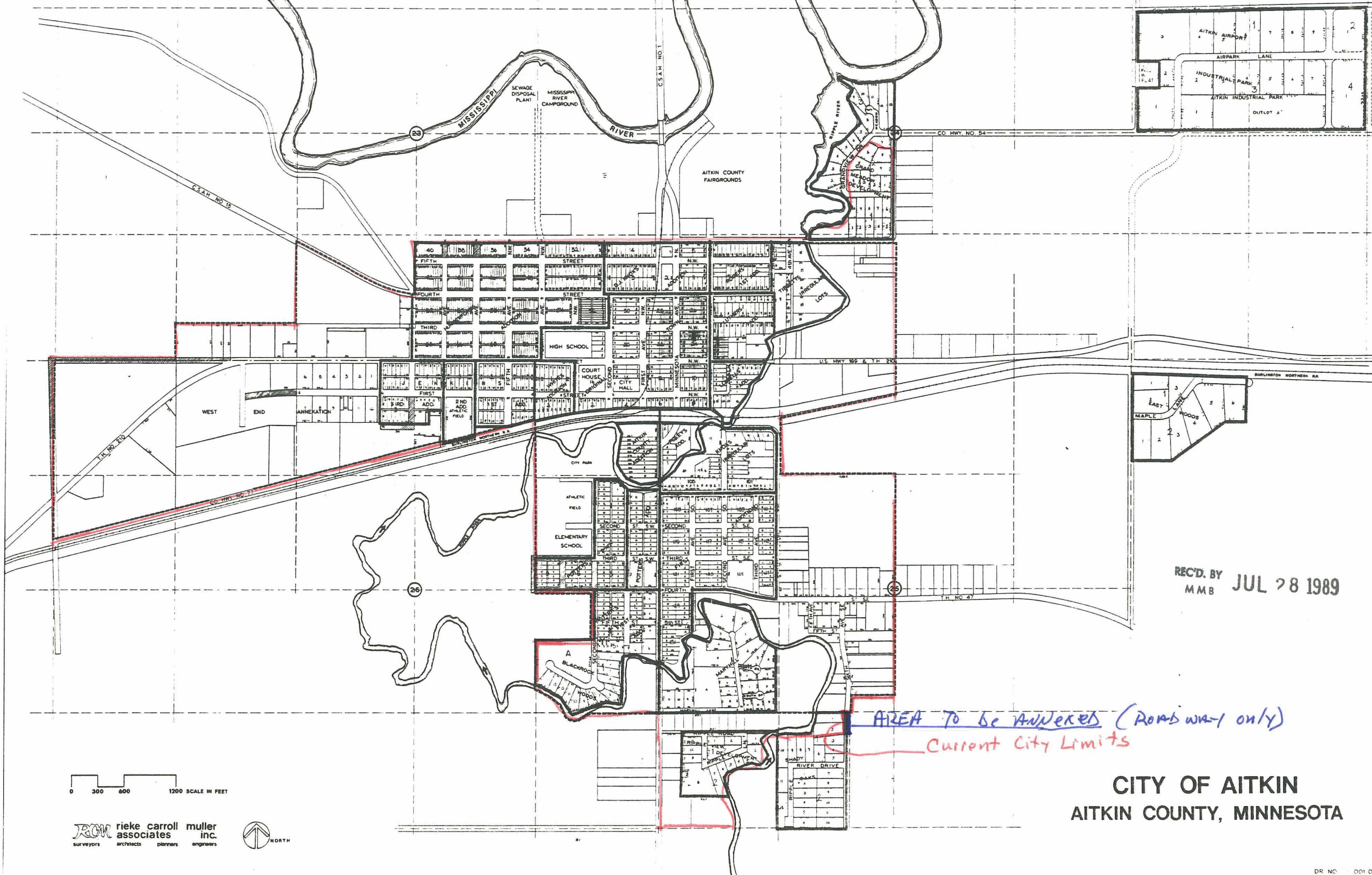
