## RESOLUTION NO. 2-O1-O2

RESOLUTION AMENDING JOINT RESOLUTION EOR ORDERLY ANNEXATION BETWEEN THE TOWNSHIP OF ROSENDALE AND THE CITY OF ST. JAMES,

WATONWAN COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES SECTION 414.0325, SUBD 1

WHEREAS, the Town of St. James and Rosendale Township along with the City of St. James, Minnesota, entered into a joint resolution of orderly annexation on August 15, 1989; and

WHEREAS, the City of St . James has received a Petition from the landowner of the herein described property more specifically described in Exhibit "A" attached hereto and incorporated herein by reference requesting that the City of $S t$. James annex said property, in that the property is about to become urban in character, the City of St. James is desirous of annexing said property, it being located within the orderly annexation areas designated in said Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF ST. JAMES AND THE TOWN BOARD OE ROSENDALE that they hereby jointly agree that the joint resolution between the Township of Rosendale and the City of St. James designated an area for annexation dated August 15, 1989, be amended to include the following:

Both the Township of Rosendale and the City of St. James agree that no alteration of the stated boundaries of this agreement is appropriate.

Furthermore, both parties agree that no consideration by the Board is necessary. Upon receipt of this resolution, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation to the City of St. James with the following described property in accordance with the terms of the joint resolution. ## EXHIBIT "A"

That part of Government Lot Five (5) of Section Nineteen (19), Township One Hundred Six (106) North, Range Thirty-one (31) West, Watonwan County, Minnesota, described as follows: Commencing at the West Quarter corner of said Section Nineteen (19); thence on an assumed bearing of North 89 degrees 37 minutes 18 seconds East, along the South line of Government Lot Five (5) of said section, a distance of 75.00 feet to right of way monument $B-4$, located on the East line of State Highway Right Of Way Plat No. 83-9, according to the recorded plat thereof, said iron monument being the point of beginning of the tract to be described; thence continuing North 89 degrees 37 minutes 18 seconds East, along said South line, a distance of 600.00 feet to an iron monument; thence North 0 degrees 00 minutes 00 seconds East a distance of 435.00 feet to an iron monument; thence South 89 degrees 37 minutes 18 seconds West a distance of 600.00 feet to an iron monument located on the East line of said State Highway Right of Way Plat No. 83-9; thence South 0 degrees 00 minutes 00 seconds West, along said East line, a distance of 435.00 feet to the point of beginning, containing 5.99 acres, subject to easements now of record in said County and State.
