WHEREAS, a joint resolution for orderly annexation was adopted by the City of Willmar and the Town of Willmar and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of Willmar pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 1, 1990, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Willmar, Minnesota, the same as if it had originally been made a part thereof:

No. 1 - NW1 Section 13, Township 119, Range 35

All that part of NW1 of Section 13, Township 119, Range 35, except those parts previously annexed.

No. 2 - SW1 Section 13, Township 119, Range 35

All that part of SW1 of Section 13, Township 119, Range 35, lying Northwesterly of the Northwesterly right-of-way line of U.S. Trunk Highway 71/State Trunk Highway 23 by-pass, except those parts previously annexed.

No. 3 - NE¹ Section 14, Township 119, Range 35

All that part of S_2^1 of NE¹ of Section 14, Township 119, Range 35, except those parts previously annexed.

No. 4 - SE¹ Section 14, Township 119, Range 35

All that part of SE¹ of Section 14, Township 119, Range 35 except those parts previously annexed.

No. 5 - NE¹ Section 23, Township 119, Range 35

All that part of E¹ of NE¹ of Section 23, Township 119, Range 35 lying Northwesterly of the Northwesterly right-of-way line of U.S. Trunk Highway 71/State Trunk Highway 23 by-pass, except those parts previously annexed.

No. 6 - NW1 Section 24, Township 119, Range 35

All that part of Government Lot 1 and the N¹/₂ of NW¹/₄ of Section 24, Township 119, Range 35 lying Northwesterly of the Southeasterly right-of-way line of U.S. Trunk Highway 71/State Trunk Highway 23 by-pass.

TOTAL AREA = 325.35 acres
