IN THE MATTER OF THE PETITION FOR THE ANNEXATION OF CERTAIN LAND TO THE CITY OF FARIBAULT

RESOLUTION FOR ANNEXATION OF AREA DESIGNATED FOR ORDERLY ANNEXATION (WALCOTT TOWNSHIP)

TO THE MUNICIPAL BOARD

WHEREAS, the City of Faribault and the Township of Walcott have an orderly annexation agreement in place; and

WHEREAS, Section 3.3 of said orderly annexation agreement indicates that the properties representing Phase III shall be annexed by January 1, 1995, or considered upon petition of the ownership of one-third of the described land area; and

WHEREAS, certain territory identified as Phase III in said orderly annexation agreement has been designated for orderly annexation to the City of Faribault, is urban in character or about to become so, and is in need of central water, sanitary sewer, and storm sewer services in the immediate future.

NOW, THEREFORE, THE CITY OF FARIBAULT RESOLVES:

- Section 1. Annexation proceedings pursuant to Minnesota Statutes 414.0325, are hereby initiated and the Municipal Board is requested to review and comment upon annexation of property, identified as Phase III in said orderly annexation agreement, and attached hereto.
- Section 2. Upon annexation, said property shall be classified as being located in and subject to the regulations of a TUD, Transitional Urban Development District, in accordance with Subdivision 6(b)(2), Appendix B (Zoning), City Code of Ordinances.


