JOINT RESOLUTION
FOR ORDERLY ANNEXATION

(1) The Town of chisago Lake and the City of Lindstrom hereby jointly agree to the following: that the following described area in Chisago Lake Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for immediate orderly annexation, to wit: Part of Government Lot 1, Section 4, T. 33 N., R. 20 W., Chisago County, Minnesota containing 2.5 acres more or less, and subject to the existing township road along the north line. Subject to easements, restrictions and reservations of record, if any. Also including an easement for drain field purposes over, under and across the South 310 feet of the North 540 feet of the East 200 feet of the West 500 feet of Government Lot 1, Sec. 4, Township 33 North, Range 20 West, Chisago County, Minnesota.

(2) That the Town Board of the Township of Chisago Lake and the City Council of the City of Lindstrom, upon passage and the adoption of this Joint Resolution and upon the acceptance by the Municipal Board, confirm jurisdiction upon the Municipal Board over the various provisions contained in this Joint Resolution.

(3) That the designated annexation area abutting the City of Lindstrom is urban or suburban in nature or is about to become so. Furthermore, the City of Lindstrom is capable of providing services to this area, and hence the annexation is in the best interests of the area proposed for annexatin.

(4) The Town of Chisago Lake and the City of Lindstrom agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, and shall within thirty (30) days, order the annexation in accordance with the terms of this Joint Resolution.

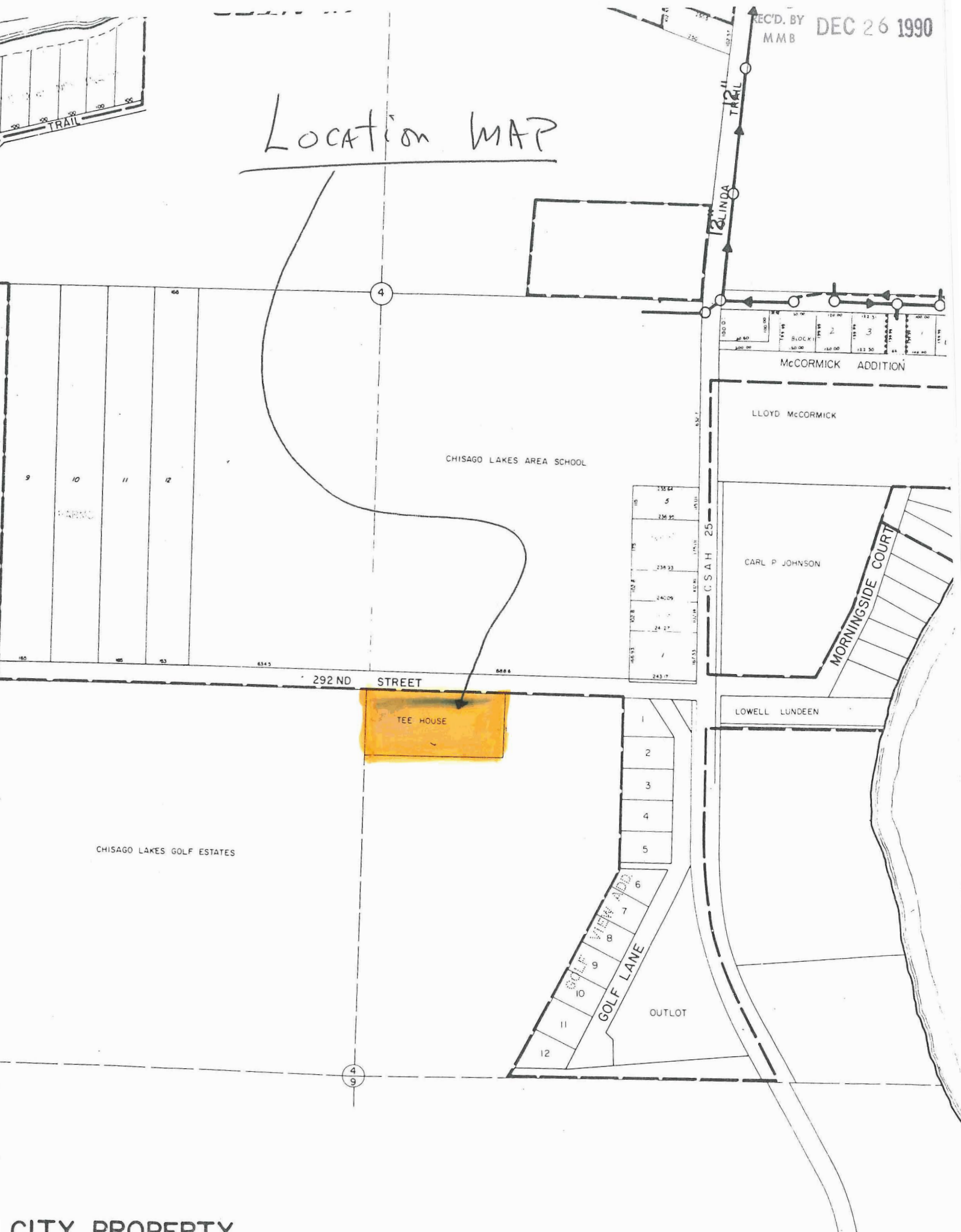
