- 2. This property shall be zoned R-3 according to the provisions of the City of Henderson Zoning Ordinance.
- 3. As a further condition of the annexation, the City of Henderson shall pay to Henderson Township the sum of \$_______. The City of Henderson further agrees that it will not annex by ordinance any additional land of Henderson Township pursuant to Minnesota Statute §414.033 by reason of such land being completely surrounded by land of the City or by reason of such land being 60 per cent or more bordered by the City.
- 4. Upon adoption of this joint resolution by both the Henderson City Council and the Henderson Town Board, such resolution shall be forwarded to the Minnesota Municipal Board with the request that they, within 30 days, order the annexation in accordance with the terms of this resolution.






