IN THE MATTER OF THE JOINT
RESOLUTION OF THE TOWN OF
SHINGOBBE AND THE CITY OF
WALKER, CASS COUNTY, MINNESOTA,
DESIGNATING AN UNINCORPORATED
AREA AS IN NEED OF ORDERLY
ANNEXATION AND CONFERRING
JURISDICTION OVER SAID AREA
TO THE MINNESOTA MUNICIPAL
BOARD PURSUANT TO MS 414.0325.

JOINT RESOLUTION
FOR ORDERLY ANNEXATION

The Town of Shingobee and the City of Walker hereby jointly
resolve and agree as follows:

1. That the following described area in Shingobee Township is
subject to orderly annexation pursuant to Minnesota Statutes
414.0325, and the parties hereto designate this area for orderly
annexation, to wit:

That part of Section 22, Township 142, Range 31, described
as follows: Commencing at the southwest corner of Government
Lot 4, said Section 22; thence North 7°55'45" West 1,887.06
feet along the west line of said Lot 4 to the point which
is South 7°55'45" East 27.96 feet from the northwest corner
of said Lot 4; thence North 82°24'41" East 45.72 feet to the
point of beginning of the tract to be described; thence
North 82°24'41" East 460.03 feet; thence North 79°18'13"
East 579.32 feet to the west line of THIRTEENTH STREET, Plat
of Pillsbury's Addition to Walker; thence South 3°26'29"
East 1,274.00 feet along the west line of said Thirteenth
Street to the north line of the tract deeded to the City
of Walker and recorded as Document #194260; thence North
86°42' West 376.78 feet along said north line to the
northwest corner of said City of Walker tract; thence South
13°10' West 110.00 feet along the west line of said City
of Walker tract; thence North 86°42' West 567.65 feet;
thence North 3°58'48" West 331.73 feet; thence North
7°38'48" West 832.63 feet to the point of beginning.

2. That the Town Board of the Township of Shingobee and the
City Council of the City of Walker, upon passage of this resolution
and upon the acceptance by the Municipal Board, confer jurisdiction
upon the Municipal Board over the various provisions contained in the
agreement.

3. That these certain properties abut the City of Walker and the annexation is in the best interests of the area proposed for annexation.

4. Both the Town of Shingobee and the City of Walker agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary.

Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.


