
Southwest Quarter of said Section 34; thence easterly on an assumed azimuth from north of 90 degrees 49 minutes 01 seconds along the south line of said Southwest Quarter 248.05 feet; thence northerly 09 degrees 28 minutes 45 seconds azimuth 163.75 feet; thence northeasterly 68 degrees 08 minutes 27 seconds azimuth 150.00 feet; thence northerly 31 degrees 53 minutes 46 seconds azimuth 276.86 feet; thence northeasterly 33 degrees 52 minutes 11 seconds azimuth 135.68 feet; thence northeasterly 33 degrees 17 minutes 36 seconds azimuth 458.98 feet; thence northeasterly 32 degrees 43 minutes 00 seconds azimuth 963.95 feet; thence northeasterly 43 degrees 23 minutes 40 seconds azimuth 231.79 feet; thence northeasterly 35 degrees 11 minutes 45 seconds azimuth 862.58 feet to the south line of said Northwest Quarter and the point of beginning; thence northeasterly 35 degrees 11 minutes 45 seconds azimuth 677.61 feet; thence northerly 353 degrees 08 minutes 20 seconds azimuth 207.83; thence northwesterly 302.95 feet along a nontangential curve concave northeasterly, having a radius of 2009.86 feet, a central angle of 08 degrees 38 minutes 11 seconds, and a chord azimuth of 319 degrees 31 minutes 48 seconds; thence westerly 270 degrees 42 minutes 25 seconds azimuth 158.80 feet; thence southerly 842.27 feet along a nontangential curve concave easterly, having a radius of 1342.39 feet, a central angle of 35 degrees 56 minutes 59 seconds, and a chord azimuth of 202 degrees 03 minutes 40 seconds; thence southerly 184 degrees 05 minutes 12 seconds azimuth 222.30 feet to the south line of said Northwest Quarter; thence easterly 90 degrees 29 minutes 15 seconds azimuth along said south line 316.54 feet to the point of beginning.


