## JOINT RESOLUTION APPROVING ANNEXATION

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Sartell and the Town of LeSauk and duly accepted by the Minnesota Municipal Board; and

WHEREAS, said joint resolution requested that certain property be annexed to the City of Sartell pursuant to M.S. 414.0325, Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, a joint public hearing of the Town Board and City Council was held on November 6, 1995 at which time all persons present wishing to be heard regarding the matter were given an opportunity to be heard and written comments were also accepted.

NOW, THEREFORE, BE IT RESOLVED: That the following described property is hereby annexed to the City of Sartell, Minnesota, the same as if it had originally been made a part thereof:

Lot 20 and Lot 21, Block 1, Lot 18 of Block 2, Lot 11, Lot 12, Lot 13, and Lot 14, Block 3, Lot 1, Lot 2, Lot 3, Lot 4, Lot 5, Lot 6 and Lot 7, Block 4, all in WOODLAWN ESTATES, according to the plat thereof, on file and of record in the Office of the County Recorder, Stearns County, Minnesota.

Together with those portions of the dedicated thoroughfares in said WOODLAWN ESTATES described as follows: 52nd Avenue that lies southerly of the westerly extension of the north line of said Lot 11 of Block 3; 51st Avenue that lies southerly of the easterly extension of the south line of said Lot 14 of Block 3; all of 360th Street.

The above described property contains 6.435 acres, more or less.

**BE IT FURTHER RESOLVED:** That said property is being annexed to the City of Sartell under zoning classification of R-1, Single Family Residence District, and has a current population of 42.
