MINNESOTA STATUTES 414                       )

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted  
by the City of Big Lake and the Town of Big Lake; and

WHEREAS, said joint resolution requests that certain property  
be annexed to the City of Big Lake pursuant to M.S. 414.0325,  
Subdivision 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances  
the Minnesota Municipal Board may review and comment, but shall  
within 30 days order the annexation of land pursuant to said  
subdivision; and

WHEREAS, on February 2, 1993, the Minnesota Municipal Board  
has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property  
is hereby annexed to the City of Big Lake, Minnesota, the same as  
if it had originally been made a part thereof:

PID #10-313-4205: Government Lot 2, Section 13, Township 33 North, Range 28  
West, Sherburne County, Minnesota, except that part of Lot 2 now platted as  
Lane J. Thomas' Lakeview Addition, or lying between said addition and the low  
water mark of that part of Big Lake now called Lake Mitchell.

Also except that part of said Government Lot 2, described as the North 350  
feet thereof.

Also except that part of said Government Lot 2, described as beginning at the

Southwest corner of Lot 1, Block 1; Lane J. Thomas' Lakeview Addition, according to the duly recorded plat thereof; thence North along the West line of said Lot 1 to the Northwest corner thereof, thence West along a line parallel with the extension Westerly of the South line of said Lot 1 for a distance of 150 feet; thence South to a point on said Westerly extension of the South line of Lot 1, a distance of 150 feet West of the point of beginning; thence West along said Westerly extension of the South line of Lot 1 a distance of 150 feet to the point of beginning; containing .64 acre, more or less.


PID #10-313-4215: The North 350 feet of Government Lot 2, in Section 13, Township 33, Range 28, except that part platted as Lane J. Thomas' Lakeview Addition, Sherburne County, Minnesota
