IN THE MATTER OF THE ORDERLY ANNEXATION)
AGREEMENT BETWEEN THE CITY OF LINDSTROM)
AND THE TOWN OF CHISAGO LAKE PURSUANT)
TO MINNESOTA STATUTES 414)

ORDER

WHEREAS, a joint resolution for orderly annexation was adopted by
the City of Lindstrom and the Town of Chisago Lake; and

WHEREAS, said joint resolution requests that certain property be
annexed to the City of Lindstrom pursuant to M.S. 414.0325, Subdivision 1;
and

WHEREAS, M.S. 414.0325 states that in certain circumstances the
Minnesota Municipal Board may review and comment, but shall within 30 days
order the annexation of land pursuant to said subdivision; and

WHEREAS, on March 17, 1993, the Minnesota Municipal Board has
reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is
hereby annexed to the City of Lindstrom, Chisago County, Minnesota, the
same as if it had originally been made a part thereof:

That Part of Government Lot A, Section 27, Township 34 North, Range
20 West, Chisago County Minnesota, described as follows:

Commencing at the southwest corner of said Section 27, thence North
87 degrees 12 minutes 50 seconds East, assumed bearing along the
south line of said Section 27, a distance of 92.94 feet; thence
North 0 degrees 00 minutes 15 seconds West, a distance of 620.73
feet to the north line of the South 620 feet of said Government Lot
1 and the point of beginning of the parcel to be described, thence
continuing North 0 degrees 00 minutes 15 seconds West, a distance
of 150.00 feet; thence North 87 degrees 12 minutes 50 seconds East,
a distance of 49.88 feet; thence North 87 degrees 12 minutes 50

seconds East to the shoreline of North Center Lake; thence southwesterly, along said shoreline, to the north line of the South 620 feet of said Government Lot 1; thence westerly, along said north line to the point of beginning.


Subject to Olinda Trail
