IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the resolution to the City of Buffalo, Minnesota,

the same as if it had originally been made a part thereof:

That part of the West 12.15 chains of Government Lot 2, Section 20, Township 120, Range 25, Wright County, Minnesota described as follows:

Beginning at the southwest corner of said Government Lot 2; thence on an assumed bearing of North 0° 35' 05" East along the west line of said Government Lot 2, a distance of 461.98 feet; thence South 81° 34' 10" East, a distance of 519.48 feet; thence South 3° 52' 50" West, a distance of 157.70 feet; thence South 89° 29' 10" East, a distance of 296.36 feet to the east line of said West 12.15 chains of Government Lot 2; thence South 0° 35' 05" West along said east line, a distance of 231.11 feet to the south line of said Government Lot 2; thence North 89° 37' 17" West, a distance of 801.91 feet to the point of beginning. The joint resolution does not make reference to which of the three statutory provisions the parties have agreed on to govern planning in the designated area.

The parties are encouraged to consider this comment in light of any further amendments that may be otherwise necessary to this agreement for orderly annexation.
