A RESOLUTION ANNEXING PROPERTY

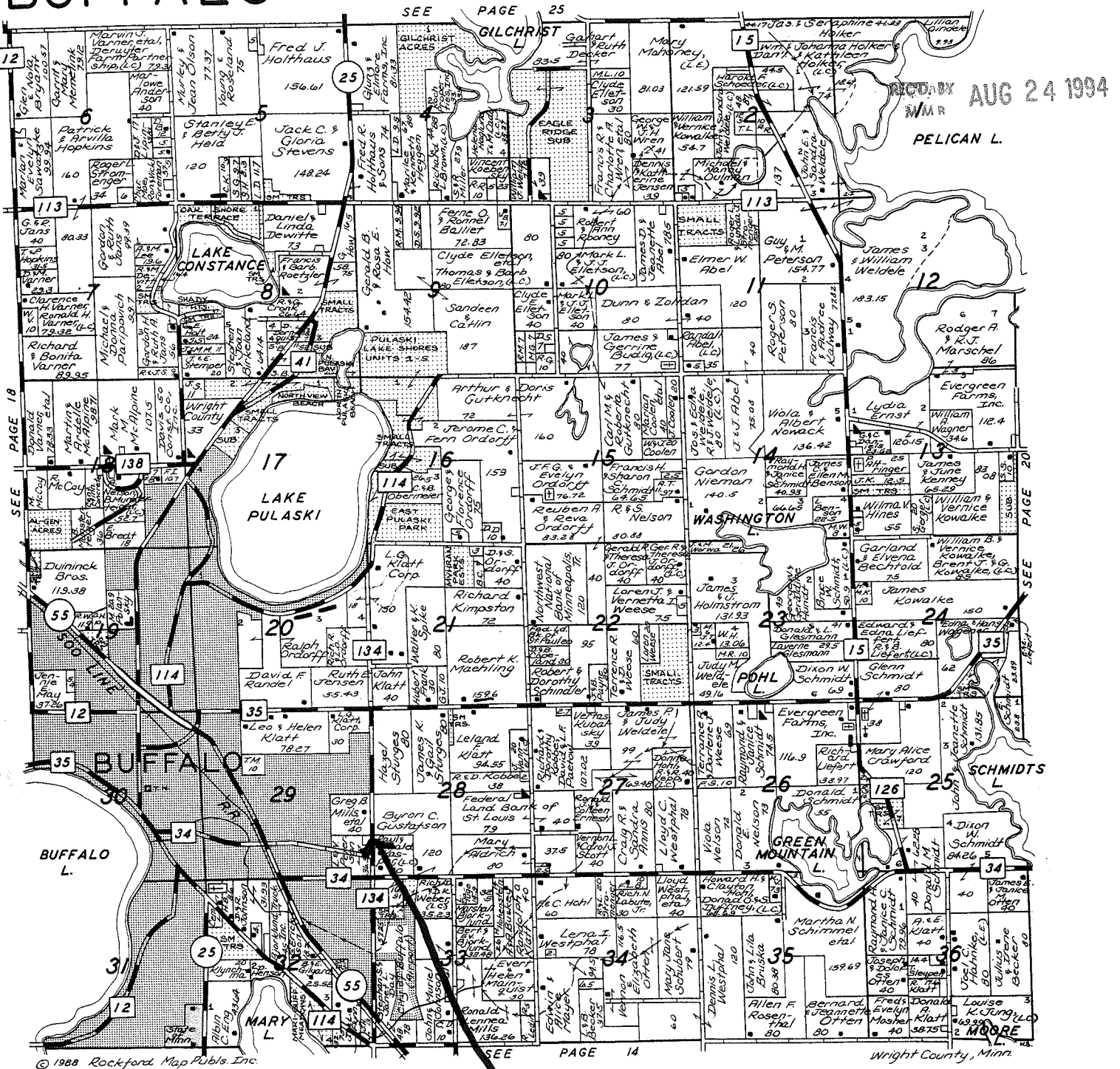
