WHEREAS, a joint resolution for orderly annexation was adopted by the City of Buffalo and the Town of Buffalo; and

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Buffalo, Minnesota, the same as if it had originally been made a part thereof:

Part of the SE 1/4 of the NW 1/4 of Section 16, T120N, R25W. A tract in Government Lot 2 beginning at a point at the centerline of Pulaski Road thence North 87 degrees east 632.2 feet more or less to the east line of government lot 2,

thence north along the east line of government lot 2, 457 feet more or less, thence in a westerly direction 491.86 feet more or less to a point on the centerline of Pulaski Road, thence southerly along the centerline of Pulaski Road 500.8 feet more or less to the point of beginning. 6.70 acres.
