JOINT RESOLUTION FOR ORDERLY ANNEXATION

The Township of Hay Creek and the City of Red Wing hereby jointly agree to the following:

1. That the following described area in Hay Creek Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:

2. That the Town Board of the Township of Hay Creek, and the City Council of the City of Red Wing, upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Agreement.

3. That these certain properties which abut the City of Red Wing are presently urban or suburban in nature or are about to become so. Further, the City of Red Wing is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Red Wing, to wit:

4. Both the Township of Hay Creek and the City of Red Wing agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.

5. That the population of the City of Red Wing be increased by  $\underline{4}$  people and that the population of the Township of Hay Creek is decreased by <u>4</u> people.
