JOINT RESOLUTION
FOR ORDERLY ANNEXATION

The Township of Alberta and the Village of Gilman hereby jointly agree to the following:

1. That the following described area in Alberta Township is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to wit:

That part of the South half of the Northeast Quarter of the Southeast Quarter (S1/2 of NE1/4 of SE1/4) Section Thirty-three (33), Township Thirty-eight (38) North, Range Twenty-nine (29) West, Fourth Principal Meridian, Benton County, Minnesota described as follows: Beginning at the southwest corner of said S1/2 of NE1/4 of SE1/4; thence North 03 degrees 23 minutes 32 seconds West, assumed bearing, on the West line of said S1/2 of NE1/4 of SE1/3 230.00 feet; thence North 89 degrees 43 minutes 41 seconds East parallel with the south line of said Northeast Quarter of the Southeast Quarter 230.00 feet; thence South 03 degrees 23 minutes 32 seconds East parallel with said west line 230.00 feet to said south line; thence South 89 degrees 43 minutes 41 seconds West on said south line 230.0 feet to the point of beginning, according to the U. S. Government Survey thereof.

2. That the Town Board of the Township of Alberta, and the City Council of the Village of Gilman, upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Agreement.

3. That these certain properties which abut the Village of Gilman are presently urban or suburban in nature of are about to become so. Further, the Village of Gilman is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area proposed for annexation. Therefore, these properties would be immediately annexed to the Village of Gilman, to wit:



Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.


