PETITION FOR ANNEXATION OF UNINCORPORATED PROPERTY TO A MUNICIPALITY

IN THE MATTER OF THE PETITION OF CERTAIN PERSONS FOR ANNEXATION OF UNINCORPORATED PROPERTY TO THE CITY OF MANKATO, MINNESOTA, PURSUANT TO MINNESOTA STATUTES, SECTION 414.0325

The Minnesota Municipal Board is hereby requested to hold a public hearing on the question of annexing certain property to the City of Mankato, Minnesota.

The petitioners for annexation are:

100% of the property owners in the area to be annexed. There are six property owners in the area proposed for annexation. The number of owners who have signed this petition is six.

The area proposed for annexation is legally described as follows:

Lot 1, Block One, Oakengate Subdivision together with that part of the Northeast Quarter of the Northeast Quarter of Section 25, Township 108 North, Range 27 West, Blue Earth County, Minnesota, described as:

Commencing at the southwest corner of Lot 1, Block One, Oakengate Subdivision, according to the plat thereof on file and of record with the Blue Earth County Recorder; thence North 00 degrees 58 minutes 00 seconds East, (assumed bearing), along the west line of said Lot 1 a distance of 426.72 feet to the northwest corner of said Lot 1; said point being the point of beginning; thence North 90 degrees 00 minutes 00 seconds East, along the north line of said Lot 1 a distance of 237.56 feet; thence North 45 degrees 58 minutes 00 seconds East, along the north line of said Lot 1 a distance of 98.00 feet; thence North 00 degrees 58 minutes 00 seconds East, along the west line of said Lot 1 a distance of 84.75 feet; thence South 08 degrees 04 minutes 55 seconds West, 45.00 feet; thence South 20 degrees 16 minutes 00 seconds West, 34.00 feet; thence South 41 degrees 55 minutes 00 seconds West, 31.00 feet; thence South 66 degrees 37 minutes 00 seconds West, 38.00 feet; thence South 79 degrees 10 minutes 00 seconds West, 117.00 feet; thence North 87 degrees 08 minutes 00 seconds West, 120.61 feet to a point on the northerly extension of the west line of said Lot 1; thence South 00 degrees 58 minutes 00 seconds West, along said extension, 22.30 feet to the point of beginning.

Said tract contains 7756 square feet (0.178 acres), subject to any and all easements of record.

- 1. The petitioners have submitted a copy of this petition to the affected Township of Mankato on April 13, 1994.
- 2. The area proposed for annexation is within 700 hundred feet of the west corporate boundary of the city and none of it is presently a part of any incorporated city or in an area designated for orderly annexation.
- 3. The total acreage of the area proposed for annexation is 3.67 acres.
- 4. The petitioners believe that all of this property is urban or suburban in character, or about to become so.
- 5. The reason for requesting the annexation is that the existing on-site septic system is failing and due to the size of the property and the fact that a significant portion of the property contains a steep wooded ravine the location of a conventional replacement system on site is not feasible. Additionally, proximity to the City of Mankato offers the availability of connection to municipal sewer service; thus ensuring a permanent wastewater treatment solution.
- 6. Pursuant to Minnesota Statutes, Section 414.0325, Subdivision 1a, the Minnesota Muncipal Board has jurisdiction to designate the area described in the petition for orderly annexation.

REQUESTING ANNEXATION OF A 3.67 ACRE AREA TO THE

WHEREAS, a property owner initiated petition to the Minnesota Municipal Board requesting annexation to the City of Mankato has been received; and,

WHEREAS, though the City of Mankato has attempted to resolve the problems that the petitioners have experienced as a result of not being located within the City's boundaries through negotiation of an orderly annexation agreement by and between the City of Mankato and Town of Mankato and said effort has not been successful.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL FOR THE CITY OF MANKATO, MINNESOTA:

That the property owners initiated petition to the Minnesota Municipal Board requesting annexation of a 3.67 acre area, legally described as Oakengate Subdivision No. 2, to the City of Mankato, a copy of which is attached, is hereby supported and endorsed.


