## **RESOLUTION NO. 1995 - 39**

## IN THE MATTER OF ANNEXING AN AREA DESIGNATED FOR ORDERLY ANNEXATION

WHEREAS, The City of Detroit Lakes and Township of Detroit have entered into a certain agreement which has been previously approved by the Minnesota Municipal Board, to provide for the orderly annexation of certain lands as described therein to the City of Detroit Lakes; and

WHEREAS, Those lands described herein are contained in the orderly annexation area, and are scheduled according to said agreement for annexation to the City; and

WHEREAS, A petition for annexation from 100% of the property owners of the territory described below has been presented to the City of Detroit Lakes.

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of Detroit Lakes that the following described lands are annexed on the date set forth further herein to the City of Detroit Lakes:

The northwest quarter (NW<sup>1</sup>/4); the northeast quarter of the southwest quarter (NE<sup>1</sup>/4 SW<sup>1</sup>/4); the southeast quarter of the southwest quarter (SE<sup>1</sup>/4 SW<sup>1</sup>/4); and that part of the east half (E<sup>1</sup>/2) which lies west of the Pelican River, also known as County Ditch. ALL IN SECTION 23, TOWNSHIP 139 NORTH, RANGE 41 WEST OF THE FIFTH PRINCIPAL MERIDIAN. The above tract contains 390 acres more or less.

BE IT FURTHER RESOLVED That a copy of the Resolution shall be filed by the City Administrator with the Minnesota Municipal Board, the Detroit Township Board of Supervisors, the Becker County Auditor, the Becker County Recorder, and the Secretary of State. BE IT FURTHER RESOLVED That the annexation of the lands described shall be effective on the date this Resolution is approved by the Minnesota Municipal Board.


