No. 193 according to Blue Earth County Hwy Right of Way Plat No. 15; thence North 04 degrees 38 minutes 59 seconds West (bearings based on Blue Earth County Right of Way Plat No. 15) on said easterly right of way line a distance of 357.78 feet to the point of beginning; thence continuing North 04 degrees 38 minutes 59 seconds West on said easterly right of way line a distance of 35.08 feet; thence North 89 degrees 10 minutes 39 seconds East, 502.10 feet; thence North 52 degrees 55 minutes 26 seconds East, 189.67 feet; thence North 89 degrees 24 minutes 39 seconds East, 186.50 feet; thence South 24 degrees 27 minutes 53 seconds West, 184.36 feet; thence South 14 degrees 39 minutes 22 seconds West, 183.27 feet; thence South 75 degrees 05 minutes 22 seconds West, 280.66 feet; thence North 00 degrees 55 minutes 53 seconds West, 265.23 feet; thence South 89 degrees 10 minutes 39 seconds West, 438.83 feet to the point beginning.
