

RESOLUTION OF THE CITY OF MANKATO APPROVING ANNEXATION PER JOINT  
ORDERLY ANNEXATION AGREEMENT WITH MANKATO TOWNSHIP

WHEREAS, a petition has been submitted by the owners of property located in Section 9, Township 108 North, Range 26 West, requesting that said property on the petition be annexed to the City of Mankato; and

WHEREAS, there are 0 residents living on said property; and

WHEREAS, the Council of the City of Mankato finds that it is in the best interest of the City to support such annexation.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of Mankato, Minnesota, hereby states that the City has no objection to the annexation of the following described property per M.S. 414.0325 and the joint resolution for orderly annexation approved by Mankato Township and the City of Mankato:

That part of the Southeast Quarter of the Northwest Quarter of Section 9 and that part of the Southwest Quarter of the Northeast Quarter of Section 9 Township 108 North Range 26 West, lying northerly of the northerly right of way line of Trunk Highway No. 14 described as:

Commencing at the East Quarter Corner of Section 9; thence northerly along the east line of the Northeast Quarter of Section 9 a distance of 333.48 feet; thence deflecting to the left 82 degrees 35 minutes 36 seconds, a distance of 2952.08 feet; thence deflecting to the right 126 degrees 30 minutes 00 seconds a distance of 375 feet more or less to a point on the northerly right of way line of Trunk Highway No. 14, said point being the point of beginning; thence continuing northeasterly along the last described line, 455 feet more or less to the point of intersection with the north line of the Southwest Quarter of the Northeast Quarter of Section 9; thence westerly along said north line and along the north line of the Southeast Quarter of the Northwest Quarter of Section 9 a distance of 1345 feet more or less to the point of intersection with the northerly right of way line of Trunk Highway No. 14; thence southeasterly along said northerly Highway right of way line, 1155 feet more or less to the point of beginning. Containing approximately 7.1 acres, subject to any and all easements of record.

The West Half of the Northeast Quarter of the Northwest Quarter of Section 9 Township 108 North Range 26 West, lying southerly of the center line of County State Aid Highway No. 3, EXCEPTING therefrom the West 100.00 feet thereof. Beginning at the Southeast Corner of the West Half of the Northeast Quarter of the Northwest Quarter of Section 9; thence northerly along the east line of the West Half of the Northeast Quarter of the Northwest Quarter of Section 9 a distance of 1320 more or less to the northeast Corner of the West Half of the Northeast Quarter of the Northwest Quarter of Section 9; thence westerly along the north line of the Northeast Quarter of the Northwest Quarter of Section 9 a distance of 100 feet more or less to the point of intersection with the center line of County State Aid Highway No. 3; thence southwesterly along said Highway Center line, 540 feet more or less to the point of intersection with the East line of the West 100.00 feet of the Northeast Quarter of the Northwest Quarter of Section 9; thence southerly along said East line, 950 feet more or less to the point of intersection with the northeasterly right of way line of Trunk Highway No. 14; thence southeasterly, easterly and southeasterly along said northeasterly highway right of way line, 180 feet more or less to the point of intersection with the south line of the Northeast Quarter of the Northwest Quarter of Section 9; thence easterly along said south line, 410 feet more or less to the point of beginning. Containing approximately 15.2 acres, subject to an easement for County Highway purposes over and across the northwesterly boundary; Also subject to any other easements of record.

The Town Board of Mankato Township, Blue Earth County, pursuant to a resolution duly adopted by the town board on 4-16, 1996 hereby states that Mankato Township has no objection to the annexation of the following described land to the City of Mankato per M.S. 414.0325 and the Joint Resolution for Orderly Annexation between the City of Mankato and Mankato Township.

That part of the Southeast Quarter of the Northwest Quarter of Section 9 and that part of the Southwest Quarter of the Northeast Quarter of Section 9 Township 108 North Range 26 West, lying northerly of the northerly right of way line of Trunk Highway No. 14 described as: Commencing at the East Quarter Corner of Section 9; thence northerly along the east line of the Northeast Quarter of Section 9 a distance of 333.48 feet; thence deflecting to the left 82 degrees 35 minutes 36 seconds, a distance of 2952.08 feet; thence deflecting to the right 126 degrees 30 minutes 00 seconds a distance of 375 feet more or less to a point on the northerly right of way line of Trunk Highway No. 14, said point being the point of beginning; thence continuing northeasterly along the last described line, 455 feet more or less to the point of intersection with the north line of the Southwest Quarter of the Northeast Quarter of Section 9; thence westerly along said north line and along the north line of the Southeast Quarter of the Northwest Quarter of Section 9 a distance of 1345 feet more or less to the point of intersection with the northerly right of way line of Trunk Highway No. 14; thence southeasterly along said northerly Highway right of way line, 1155 feet more or less to the point of beginning.
