WHEREAS, a joint resolution for orderly annexation was adopted by the City of Annandale and the Town of Southside; and

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Annandale, Minnesota, the same as if it had originally been made a part thereof:

> The Southeast Quarter of the Southwest Quarter, Section 25, Township 121, Range 28, Wright County, Minnesota, and

> The South Half of the Southeast Quarter, Section 25; the Northeast Quarter of the Northwest Quarter, the North Half of the Southeast Quarter of the Northwest Quarter, the West Half of the Northeast Quarter and

the Northeast Quarter of the Southeast Quarter, Section 36, Township 121, Range 28, Wright County, Minnesota, and

The South Half of the Southeast Quarter of the Northwest Quarter of Section 36, Township 121, Range 28, Wright County, Minnesota, except therefrom:

Commencing at the Northeast corner of the Northeast Quarter of the Northwest Quarter, Section 36, Township 121, Range 28; thence run South along the East line 46 rods to an iron post for the point of beginning; thence run West 32 rods; thence South 25 rods; thence East 32 rods to the East line thereof; thence North 25 rods to the point of beginning. Said area contains approximately 315 acres.

IT IS FURTHER ORDERED: That the effective date of this order is March 16, 1995.

IT IS FURTHER ORDERED: That the effective date of this amended order is August 4, 1995.
