JOINT RESOLUTION FOR ORDERLY ANNEXATION

The Township of Chisago Lake and the City of Lindstrom hereby jointly agree to the following:

1. That the following described area in Chisago Lake Township, Chisago County, is subject to orderly annexation pursuant to Minnesota Statutes 414.0325, and the parties hereto designate this area for orderly annexation, to-wit:

That part of the Northwest Quarter of the Northeast Quarter of Section 9, Township 33 North, Range 20 West, Chisago County, Minnesota, described as follows: Commencing at the northeast corner of said Northwest Quarter of the Northeast Quarter: thence North 89 degrees 53 minutes 12 seconds West, assumed bearing along the north line of said Northwest Quarter of the Northeast Quarter, a distance of 579.26 feet to the point of beginning; thence South 15 degrees 02 minutes 44 seconds East, a distance of 252.75 feet; thence westerly, to the southeast corner of Lot 10, Block 1 of the recorded plat of G-O-A Estates; thence northerly, along the east line of said Lot 10, to the northeast corner of said Lot 10 and the north line of said Northwest Quarter of the Northeast Quarter; thence easterly, along said north line, to the point of beginning.

Subject to and together with any other valid easements, restrictions and reservations of record.

- 2. That the Town Board of the Township of Chisago Lake and the City Council of the City of Lindstrom, upon passage and adoption of this resolution and upon acceptance by the Municipal Board, confer jurisdiction upon the Minnesota Municipal Board over the various provisions contained in this agreement.
- 3. That these certain properties which abut the City of Lindstrom are presently urban or suburban in nature or about to become so. Further, the City of Lindstrom is capable of providing services to

the area within a reasonable time and the annexation is in the best interests of protecting the public health, safety or welfare of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Lindstrom, to-wit:

That part of the Northwest Quarter of the Northeast Quarter of Section 9, Township 33 North, Range 20 West, Chisago County, Minnesota, described as follows: Commencing at the northeast corner of said Northwest Quarter of the Northeast Quarter: thence North 89 degrees 53 minutes 12 seconds West, assumed bearing along the north line of said Northwest Quarter of the Northeast Quarter, a distance of 579.26 feet to the point of beginning; thence South 15 degrees 02 minutes 44 seconds East, a distance of 252.75 feet; thence westerly, to the southeast corner of Lot 10, Block 1 of the recorded plat of G-O-A Estates; thence northerly, along the east line of said Lot 10, to the northeast corner of said Lot 10 and the north line of said Northwest Quarter of the Northeast Quarter; thence easterly, along said north line, to the point of beginning.

Subject to and together with any other valid easements, restrictions and reservations of record.

- 4. Both the Township of Chisago Lake and the City of Lindstrom agree that no alteration of the stated boundaries of this agreement is appropriate. Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days, order the annexation in accordance with the terms of this joint resolution.
- 5. That the effect of annexations on population shall be resolved whenever possible by agreement of parties. If there is failure to reach such agreement, the question shall be resolved by the Minnesota Municipal Board.
- 6. That the area proposed for annexation is not included in any other orderly annexation agreement area.
- 7. That the area proposed for annexation does not abut any other municipality or township.
- 8. That the reason for the proposed annexation is to facilitate the a re-subdivision of adjacent property.

## PETITION FOR ANNEXATION
