CITY AND THE TOWN OF CHISAGO LAKE)	<u>ORDER</u>
PURSUANT TO MINNESOTA STATUTES 414)	

WHEREAS, a joint resolution for orderly annexation was adopted by the City of Chisago City and the Town of Chisago Lake; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Chisago City pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on June 6, 1996, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the

City of Chisago City, Minnesota, the same as if it had originally been made a part thereof:

That part of Lot 20, Chisago Villas, Chisago County, Minnesota, to include the adjacent right-of-way to corporate limits. ~~Lot twenty (20) Chisago Villas except that part of Lot twenty (20) of Chisago Villas described as follows: Commencing at the most Northerly corner of Block 64; thence Southeasterly along the most Easterly line of Block 64, 50 feet; thence Northeasterly, at a right angle, 70 feet to the point of beginning; thence continuing Northeasterly, along the last described course, 15 feet; thence Southeasterly, at a right angle, 10 feet; thence Southwesterly, at a right angle, 15 feet; thence Northwesterly, at a right angle, 10 feet to the point of beginning all in Township 33, Range 20, Sections 17 and 18.~~

IT IS FURTHER ORDERED: That the effective date of this order is June 6, 1996.

IT IS FURTHER ORDERED: That the effective date of this amended order is November 10,

1998.


