WHEREAS, a joint resolution for orderly annexation was adopted by the City of Stillwater and the Town of Stillwater; and

WHEREAS, a resolution was received from the City of Stillwater indicating their desire that certain property be annexed to the City of Stillwater pursuant to M.S. 414.0325; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Director of Strategic and Long Range Planning may review and comment, but shall within 30 days order the annexation pursuant to said subdivisions; and

WHEREAS, on April 15, 2004, the Director has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed in accordance with the terms of the joint resolution to the City of Stillwater, Minnesota, the same as if it had originally been made a part thereof:

That part of the intersection of County Roads 12 and 15 and that part of the right-of-way of County Road 15, as described in Book 291 of Deeds, Page 261, as further described as that part of the SW ¼ offsection 30, Town 30 North, Range 20 West, lying east of and adjacent to the following described centerline: Beginning at a point on the South line of the Northeast Quarter of Section 25, Township 30 North, Range 20 West, a distance of 2.18 feet West of the East Quarter Corner of Section 25; thence North on a 2 30' curve to the left (central angle

equals 5) a distance of 100 feet; then North 5, 9', 20" West, a distance of 233.4 feet to Engineering Station 86+39, at which point the 60 foot right- of- way line intersects the existing 30 foot right- of- way line;

and

All that part of the Southwest Quarter of the Northwest Quarter of Section 30, Township 30, Range 20, Washington County, Minnesota, lying southerly of the north 264.00 feet thereof, and northerly of the following described line: Commencing at the northeast corner of said Southwest Quarter of the Northwest Quarter; thence South 01 degrees 10 minutes 54 seconds East, assumed bearing, along the easterly line thereof, 264.00 feet to the point of beginning of the line being described; thence westerly at right angles and on a bearing of South 88 degrees 49 minutes 06 seconds West 1049.77 feet, more or less, to the westerly line of said Southwest Quarter of the Northwest Quarter and the end of the line described.

Together with that part of Southwest Quarter of the Northwest Quarter and that part of the Northwest Quarter of the Southwest Quarter, Section 30, Township 30, Range 20 Washington County, Minnesota, being the intersection of County Roads 12 and 15, described as follows:

Beginning at a point 2.18 feet west of the East quarter corner of said Section 25; thence northerly on 02 degree 30 minutes curve to the left, central angel 05 degrees for a distance of 100.00 feet; thence North 05 degrees 09 minutes 20 seconds West, a distance of 315.16 feet; thence northerly on a curve, 03 degree to the right with a central angle of 10 degrees 15 minutes, a distance of 341.67 feet; thence North 05 degrees 05 minutes 40 seconds East, a distance of 284.56 feet to Engineers Station 93+57, said point being 12.22 feet west and 1038.20 feet north of the East Quarter corner of said Section 25, and line there terminating.
