WHEREAS, a joint resolution for orderly annexation was adopted by the City of Rose Creek and the Town of Windom; and

WHEREAS, said joint resolution requests that certain property be annexed to the City of Rose Creek pursuant to M.S. 414.0325, Subd. 1; and

WHEREAS, M.S. 414.0325 states that in certain circumstances the Minnesota Municipal Board may review and comment, but shall within 30 days order the annexation of land pursuant to said subdivision; and

WHEREAS, on December 6, 1996, the Minnesota Municipal Board has reviewed and accepted the resolution for orderly annexation;

IT IS HEREBY ORDERED: That the following described property is hereby annexed to the City of Rose Creek, Minnesota, the same as if it had originally been made a part thereof:

Section 36 Township 102 Range 17 NE 1/4, NW 1/4, lying NE of Highway 56, the SW right of way line of Highway 56, 23.37 acres of land; and Section

25 Township 102 Range 17 SE 1/4, SW
40
1/4, 36 acres of land.




