JOINT RESOLUTION  
FOR ORDERLY ANNEXATION

The Township of Home and the City of Sleepy Eye hereby jointly agree  
to the following:

1. That the following described area in Home Township is  
subject to orderly annexation pursuant to Minnesota Statutes 414.0325,  
and the parties hereto designate this area for orderly annexation, to-  
wit:

THAT PART OF THE SOUTHEAST QUARTER AND OF LOT M-4 OF M-2 OF THE  
SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER ALL IN SECTION 29,  
TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA;

Being Westerly of the Southerly prolongation of the east line of  
Lot E of the Southeast Quarter of the Northeast Quarter of said  
Section 29 and Northerly of the southerly right-of-way line of  
the Dakota Minnesota & Eastern Railroad; excepting therefrom the  
following properties:

Sleepy Hollow First Addition,  
Sleepy Hollow Second Addition,  
Sleepy Hollow Third Addition all in the City of Sleepy Eye,  
and  
Outlot A of Kroschel's Subdivision of the Northwest Quarter of  
the Southeast Quarter of said Section 29,

along with,

THAT PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER AND OF  
THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER, ALL IN SECTION 29,  
TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA;

Being Northerly of U.S. Trunk Highway No. 14 right-of-way and  
Southerly of the Dakota Minnesota & Eastern Railroad right-of-  
way excepting therefrom the following properties:

Lot A & B of said Northeast Quarter of the Southeast Quarter,  
Lot A & B of said Southeast Quarter of the Southeast Quarter, and  
Seven Gables Addition in the City of Sleepy Eye.

2. That the Town Board of the Township of HOme, and the City Council of the City of Sleepy Eye upon passage and adoption of this resolution and upon the acceptance by the Municipal Board, confer jurisdiction upon the Municipal Board over the various provisions contained in this Agreement.

3. That these certain properties which abut the City of Sleepy Eye are presently urban or suburban in nature or are about to become so. Further, the City of Sleepy Eye is capable of providing services to this area within a reasonable time, and the annexation is in the best interest of the area proposed for annexation. Therefore, these properties would be immediately annexed to the City of Sleepy Eye, to wit:

THAT PART OF THE SOUTHEAST QUARTER AND OF LOT M-4 OF M-2 OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER ALL IN SECTION 29, TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA;

Being Westerly of the Southerly prolongation of the east line of Lot E of the Southeast Quarter of the Northeast Quarter of said Section 29 and Northerly of the southerly right-of-way line of the Dakota Minnesota & Eastern Railroad; excepting therefrom the following properties:

Sleepy Hollow First Addition,  
Sleepy Hollow Second Addition,  
Sleepy Hollow Third Addition all in the City of Sleepy Eye,  
and  
Outlot A of Kroschel's Subdivision of the Northwest Quarter of the Southeast Quarter of said Section 29,

along with,

THAT PART OF THE NORTHEAST QUARTER OF THE SOUTHEAST QUARTER AND OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER, ALL IN SECTION 29, TOWNSHIP 110 NORTH, RANGE 32 WEST, BROWN COUNTY, MINNESOTA;

Being Northerly of U.S. Trunk Highway No. 14 right-of-way and Southerly of the Dakota Minnesota & Eastern Railroad right-of-way excepting therefrom the following properties:

Lot A & B of said Northeast Quarter of the Southeast Quarter,  
 Lot A & B of said Southeast Quarter of the Southeast Quarter  
 and  
 Seven Gables Addition in the City of Sleepy Eye.

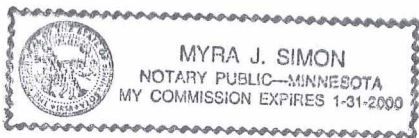

Furthermore, each party agrees that no consideration by the Municipal Board is necessary. Upon receipt of this resolution, passed and adopted by each party, the Municipal Board may review and comment, but shall, within thirty (30) days order the annexation in accordance with the terms of this joint resolution.

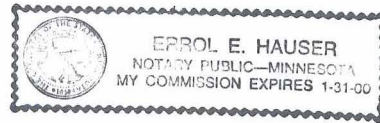
